## Discussion:

Amongs other things, the following was discussed:

- Friends of Elim and Opsienersraad did not support the proposal.
- The building falls in a Provincial Heritage Site and in the main Church Street gateway entrance.
- A site inspection was conducted by LB and LM who reported that work has proceeded on site.
- The east wing extension and the second floor additions is an inappropriate intervention, and would impact negatively on the significance of the Church Street context.
- It is recommended that the height be reduced and the usage of loft spaces be proposed as an alternative to a full second storey.
- It is recommended that thatch is used as a roof material on the Church Street elevation. Corrugated iron sheeting can be used as a roof material for additions that are not visible from Church Street.

#### **RECORD OF DECISION:**

The Committee resolved not to approve the proposal in its current form as it is detrimental to the heritage significance of the Church Street context.

   Alternatively the addition could be built on the ground level.
- Roof Form: A hipped roof, possibly with dormers, would be preferable over the proposed roof form. The roof pitch must match the existing building.
- Cladding Material: The use of brick and mortar or corrugated cladding is preferred over Nutec cladding
- Fenestrations: The fenestrations must be rectangular and vertical in nature.
