




Figure 1. Erf Details

Reason for Site Inspection:

Heritage Western Cape (HWC) received a notification that a fragment of a human skull was pick up on the beach by member of the public. He took the piece home and sent in photos of the maxilla, the sandbank where he found it as well, as the GPS location to HWC. A rib end was identified in one of the photos of the site.

Heritage Officers went to the site to access if there were any more human remains being exposed and whether a full excavation would be needed.

Findings and Discussion:

The GPS co-ordinates led us straight to the correct sand bank (the rib end in the photo was immediately located.

The sand bank is above the beach/high water line and below the dunes that abut the beach. The bank is partly aeolian sand that has hardened to a small degree and soft dry sterile sand. There is some shell on the surface as well as some plants growing.

The sand was scraped bank on the top surface of the bank and the front to ascertain where there might be more of the human remains. Modern rubbish (such as bottle tops and pieces of plastic) as well butchered animals' bones were uncovered.

No more human remains were uncovered or deemed to be at risk from the erosion of the bank. It is unknown if there is more of the human skeleton in the sandbank, however that would require a full excavation of the bank. As any bones are still well covered it is best to not investigate and disturb them. However, a more likely scenario is that the found fragment was isolated and the rest of the skeleton has either already eroded out and washed away at some time in the past or removed previously while this place left behind.

The recovery of the fragment from member of the public is still underway to the date of writing this report, as he has stopped responding to communication.

Once it has been collected, they will be sent to Dr V. Gibbon at the University of Cape Town for proper identification.

Recommendations:

- Local municipality be contact to make aware of the archaeological sensitive of the dune
- The bone to be stored with other accidental finds until re-burial can be organized.
