- The committee noted that only two heritage resource identified on the site, one ruin been a small concrete slab and rainwater tank, and the other of the ruins of a fireplace and flue, concrete slab and two rainwater tanks. These ruins may well be from beach cottages dating back to the 1900's.
- There were no records of these ruins in historical aerial photographs.
- The ruins are regarded as NCW.
- The Planning Motivation Report confirms that the proposed development is in line with all legislation and planning policies in place.

#### DECISION

The Committee resolved to endorse the HIA prepared by Andre Vercueil Professional Architects dated 17 February 2023 as meeting the requirements of Section 38 (3) of the NHRA and the following recommendations on page 33;

- 1. That the proposed consolidation and re-zoning of the Erven in the application and submission process (which have been motivated in terms of the local by-laws and in accordance with the requirements of the Bitou SDF, SPLUMA and LUPA), is to proceed, as it also conforms to the appropriate heritage principles identified in this report.
- 2. The findings of the Visual Impact Assessment Report, the Archaeological Impact Assessment Report and the Paleontological Impact Assessment Reports, are that no heritage resources will be negatively affected by the proposed development. It is therefore recommended that the application is endorsed by HWC with the necessary mitigation measures as outlined in the report.
- 3. The proposed development is to be integrated and rolled out throughout the planning, construction and the post construction phases according to the specialist reports, which will assure a sustainable project.
- 4. Should pre-colonial heritage resources be uncovered during construction, these must be reported immediately to the Archaeologist and Heritage Western Cape to indicate a way forward. If human remains be surfaced, they must be cordoned off and not disturbed any further, until an investigation

has been concluded.

- 5. If any Strandloper middens or large mammal bones or any other significant paleontological resources be uncovered during construction these must be reported immediately to the Paleontologist and Heritage Western Cape to indicate a way forward.
- 6. An EIA process is under way and any potential impacts will be identified and reported, with associated mitigation.
- 7. That the Architectural Design Guidelines proposed for the development be adopted by HWC to mitigate the colours, heights, disturbance areas, maximum footprint, vegetation, etc, which will all contribute to a smaller visual impact on the landscape.
- 8. That the necessary measures be implemented during the construction phase to protect the natural vegetation, to control the noise, dust and visual intrusion.
- 9. That the developers appoint a landscape consultant to recommend and implement the introduction of an indigenous landscape plan to protect the existing indigenous vegetation and to prepare a landscape plan for implementation in the private and common areas.
- 10. That the comments from the interested and affected parties, the conservation bodies and the Local Authority regarding the proposed development be considered and worked into the recommendations.
- 11. The existing access track from Robberg Bay Road to the proposed site access is to be upgraded to a hard surface with the cost to be met by the developer.

- Archaeology- An AIA conducted for the proposed expansion of a gas turbine in 2007 by ACO found no surface though vegetational clearing was still to be conducted. The area at large has since been further developed since then which is indicative of the area holding no heritage resources of significance.

# 12.2 Proposed residential development Knysna on Portion 38 of Farm Ganse Vallei 444, Plettenberg Bay, S38(8)-HIA

Case No: HWC22101907AM1019

Ms Ayanda Mdludlu introduced the item.

#### DISCUSSION

• **Desktop Archaeological Impact Assessment**- A field survey conducted on the 10th of October 2022 revealed no evidence of pre-colonial/historical period archaeology on the site. It is noted that existing dense vegetation did affect the survey. Two small stone features consisting of quartzite cobbles identified on the northern edge of the property, that according to a report written by Nilssen (2009) may have been relocated and assessed as being either graves for pets or burials of small children. The reports are not convinced that the stone piles are grave markers and cannot be verified from a visual inspection. The track logs seemed sparse that can be attributed to the dense vegetation mentioned in the text.

#### DECISION

The Committee resolved to endorse the HIA prepared by Perception Planning dated March 2023 as meeting the requirements of Section 38 (3) of the NHRA and the following recommendations on page 18;

is recommended that development proposals are endorsed subject to the following recommendations to be assimilated into future outcome(s) of the NEMA process currently underway:

• Alternative 1, the preferred alternative, is supported.

• A buffer of 5 m must be implemented around the two stone features. They must be fenced during the earth moving activities, to protect them from accidental impact.

• An archaeologist must be on site to monitor earth moving activities, particularly those areas around the stone features.

If any human remains or significant archaeological materials are exposed during development activities, then the find should be protected from further disturbance and work in the immediate area should be halted and Heritage Western Cape must be notified immediately. These heritage resources are protected by Section 36(3)(a) and Section 35(4) of the NHRA (Act 25 of 1999) respectively and may not be damaged or disturbed in any way without a permit from the heritage authorities. Any work in mitigation, if deemed appropriate, should be commissioned and completed before construction continues in the affected area and will be at the expense of the developer. The above recommendations should be included in the Environmental Management Program

(EMPr) for the proposed residential development.

As per the APM Committee decision dated 2nd June 2009 (Case No 37/ROD ID 418):

• Archaeological monitoring of bulk earthmoving activities must take place.

• The Archaeologist must report any occurrences of fossils and a Palaeontologist must record the exposed sections before the trenches are closed up.

The HWC Chance Fossil Finds Protocol to be implemented and included in the Environmental Management Programme Report.Provision of adequate public (pedestrian) access to the estuary should be addressed in the environmental process.

## 12.3 Propose mining quarry extension on Potion 11 (a Portion of Portion 1) of Farm Hartenbos No. 217, Kleingeluk Quarry, Mossel Bay, S38(8)-HIA

Case No: 22050905AM0523E

Ms Ayanda Mdludlu introduced the item.

#### DISCUSSION

- Archaeological Impact Assessment- No stone age resources were found n Section E. A lowdensity scatter of ESA tools was identified in Section F. None were formal tools. Few ESA chunks were found in Section G which is a steep slope with dense vegetation. Area is not deemed to have had human occupation meaning tools were likely discarded in the area. These tools earned a grading of not conservation worthy.
- **PIA:** The Kirkwood, Buffelskloof, Hartenbos and Grahamstown formations have been identified as underlaying the subject site. Almond (2009) states that besides the Hartenbos and Grahamstown formations having abundant well-preserved fossil wood, the other formations hold very little fossil materials within the study area.
- VIA: It is acknowledged that the Visual Impact of unplanned mining of the upper east facing slopes of Sections B, E, F and G, will result in `significant visual impacts on the residents of Outeniquasbosch and Monte Christo'. This area is however, already sanctioned for mining and this proposal is for its extension.
- **Public engagement-** No heritage related comments were received from the Mossel Bay Municipality, or any Interested and Affected Parties. Heritage Mossel Bay (a Registered Conservation body) were sent a copy of the HIA report but failed provide comment.

#### DECISION

The Committee resolved to endorse the HIA prepared by CRM dated June 2022 as meeting the requirements of Section 38 (3) of the NHRA and the following recommendations on page 25; Archaeology

No mitigation is required prior to proposed quarrying operations commencing.
Palaeontology

1. The Mine Manager is encouraged to rescue and set aside larger blocks of petrified wood for palaeontological examination. Where prominent layers of coalified plant material ("lignite / peat / charcoal") or other fossils such as vertebrate bones and teeth are exposed by mining, Heritage Western Cape or a qualified palaeontologist should be notified so that relevant field observations and sampling can be conducted at the earliest opportunity (Almond 2009:1).

The above recommendations must be incorporated into the Environmental Management Programme (EMPr) for the proposed project.

Monitoring by a paleontologist to be done to assist Mine Manager in the rescuing of artefacts.

# 12.4 Proposed excavation, removal from its original position, collection, analysis, dating & restoration on Cape Farm Vissershok 957, Potsdam Road, Vissershok, CT, S35-Archaeological permit

Case No: 17092810AS1025E

Ms Ayanda Mdludlu introduced the item.

#### DISCUSSION

• This werf served as a Dutch East India outpost from the 1680s to 1791. A PhD study on the sequence of settlement patterns before and after the colonial period by finding the footprint of the VOC cattle outpost's werf walls was to conduct test pit excavations and this is the final report from that study.

- HWC required that a report on the Vissershok site layout and architectural analysis and interpretation be prepared by a heritage consultant. This has been fulfilled as the heritage practitioner's assessment is under Addendum A and cultural historian's consultation on the architecture is included in the report.
- The Vissershok site is located in a region of low paleontological sensitivity in which to date no fossils have been found (Orton 2018).
- Although no late 17th century artefacts could be found and current werf walls and entrance gates had undergone structural change, archaeological and documentary sources do point to what could be considered the footprint of the VOC outpost werf walls. The study has revealed points for further investigations in future to uncover the larger unknowns of the earliest VOC facilities.
- The report has met the requirements.

A letter to be issued acknowledging receipt of report and its compliance with HWC's requirements.
