- The site lies within the cultural landscape of the Two Rivers Urban Park. The overall grading of the surrounding area of the site is IIIA while the site itself is marked as requiring further investigation. The applicants believe that a no-go area option would result in the loss of potential social and economic benefits. The site mostly has intangible significance. The Victorian House identified on site is graded IIIC and the guard house is graded not conservation worthy and younger than 60 years.
- Intangible heritage significances can no longer be tied to a specific space or place according to the report. Precolonial and indigenous occupation of the area cannot be charted and so an acknowledgment of this part of history in all developments of this area is an offered thought. The river is considered as part of recreational use in the area and therefore has symbolic and aesthetic significance. Developmental principals to ensure that the site continues to contribute ecologically, culturally and scenically to the landscape, are offered in the report. There is some

historical farming associated with the site, but not enough information is gathered to formulate a heritage indicator. The rural openness aspect of the site as a heritage indicator is challenged by the report stating that the site has fluctuated between being developed and undeveloped.

- Malmesbury Group is identified as the underlying bedrock and is classified as low sensitive. As such, fossils are not expected to occur.
- Features and cultural material associated with The Cottage would likely hold moderate to low significance. Any remains associated with the Old Asylum or the Valkenburg homestead would be considered highly significant. Any burials regardless of age or origin would be afforded a IIIA grading.
- Visual informants to inhibit larger buildings and reinforce the former rural and wilderness characteristics of the site are offered in the report. The VIA has found that though the proposal is intrusive on the receiving environment, the impacts could be mitigated to low.
- As some I&APs raised concerns, HOMs referred to the matter to IACom for their expertise.
