FEEDBACK REPORT ON A SITE VISIT TO DE NOVO ESTATE

HERITAGE WESTERN CAPE INVENTORIES, GRADING & INTERPRETATION COMMITTEE

2 FEBRUARY 2022

APPLICANT: Aaron Meselaar: High Commissioner Griqua Royal House

1. BACKGROUND

The proposed nomination dossier for declaration as Provincial Heritage Site was tabled at a meeting of the IGIC on 5 November2021. The committee requested further information, including:

• A site visit was conducted by the Committee on Wednesday 2 February 2022.

2. PRESENT

In addition to studying the submissions made in respect of this matter, the methodology adopted by the committee for the site visit included a physical inspection of the study area, photographs and oral history from local inhabitants of the area.

The following observations were made during the course of the site visit and, in addition to the information already at hand, may be considered during formal discussion during the meeting:

- The study area presents varying layers of heritage value, in addition to those identified as part of the identification process and the compilation of the dossier. These include the cemetery, community hall, rehabilitation centre, school and other key tangible elements that represent intangible memory that could lend value to the declaration narrative.
- The direct association with the community of the area provides a strong link with the area as a settlement.
