

## CALL FOR COMMENT ON THE PROPOSAL TO EXEMPT DEMARCATED AREAS IN CERTAIN DEVELOPMENT FOCUS AREAS FROM THE REQUIREMENTS OF SECTIONS 34 AND 38 OF THE NATIONAL HERITAGE RESOURCES ACT (NHRA)

The City of Cape Town and Heritage Western Cape are calling for comments on the proposal to exempt the following demarcated areas situated in Development Focus Areas (DFAs) from the requirements of Sections 34 and 38 of the National Heritage Resource Act (Act 25 of 1999):

1. Airport Industria DFA
2. Atlantis DFA
3. Flamingo DFA
4. Kuils River DFA
5. Mitchells Plain DFA
6. Ottery/Landsdowne DFA
7. Prioritised Areas North of Voortrekker Road
