# 12.4 Proposed expansion of agricultural activities, RE 9 of Farm 205 Kransvlei, Clanwilliam – S38(8)-NID Case No: 220114076AM0422E

- Project area has underlying Nardouw sediments and proposed activities are unlikely to impact significant fossil material as these formations do not contain any fossils according to consultations done with Prof Bamford. The report also claims that with the Fossil Finds Procedure included in the EMP, impacts could be further minimized.
- A (rock)shelter with a proposed grading of IIIB with a scatter of MSA artefacts is yet to be identified in the area of agricultural expansion where significant impact could occur. The report recommends that should it be inside the area of proposed works, mitigations must be made in an Archaeological Impact Assessment.
- 18<sup>th</sup> and 19<sup>th</sup> century buildings graded IIIA will not be impacted.
- There is reason to believe that heritage resources will be impacted on.
