STATUTORY PRICE INCREASE 2022: CONTRACT WCPT-TR 01/2017/2018: FRAMEWORK AGREEMENT FOR THE TRANSVERSAL PROVISION OF SECURITY SERVICES TO THE WESTERN CAPE GOVERNMENT FOR THE PERIOD ENDING 31 MARCH 2023

1. PURPOSE

- 1.1 The purpose of this communiqué is to inform institutions of the statutory price increase of the transversal security services framework agreement for Western Cape institutions for the period 1 March 2022 to 31 March 2023.

2. SECURITY FRAMEWORK RATES FOR 2022/23

- 2.1 The Collective Agreement (hereafter referred to as "the Agreement") was concluded in the National Bargaining Council for the Private Security Sector in terms of section 31 of the Labour Relations Act, 1995 and gazetted on 20 February 2020.
- 2.2 The above-mentioned agreement is binding on employers and employees in the industry with effect from 1 March 2022 and shall remain in force until 31 March 2023. This necessitated the revision of the provincial framework agreement contractual average pricing rates.
- 2.3 The Provincial Treasury adjusted the mutually agreed monthly prices in accordance with the above-mentioned agreement. The increases are reflected hereunder in relation to the service types and in terms of urban and rural areas of the framework:
