CIRCULAR H 03 /2022

CONTACT TRACING, ISOLATION, QUARANTINE AND TESTING: WITHDRAWAL OF H 221/2021

Circular H 221/2021 based upon the now withdrawn national guidelines on contact tracing, quarantine, isolation and testing had still been in place in the province until now as we had been awaiting an announcement on the replacement of the national circular.

Whilst the basis of H 221/2021, based upon the national circular, has much scientific merit and had been thought through carefully, it does conflict with existing legislative prescripts which had not changed. As a result, H 221/2021 must now be withdrawn.

The implication of the withdrawal of H 221/2021 is that we would automatically then revert to the policy positions that were in place before H221/2021 was issued. The attached table below summarises the H221/2021 positions, and the prior positions to which we have to revert to.

One of these prior positions is the quarantine of HCWs contained in Circular H 219/2021. The DOH Guidelines state that, by agreement, HCW's can test on day 5 and if negative and well, to return to work and follow restrictions. We will therefore have to revert to this position as contained in the DOH Guidelines.

We would however continue to discuss the merits contained within Circular H 221, as we believe that these suggestions are both rational and reasonable.

Once we have clarified these issues and the NDOH has provided clear guidelines we will re-issue a circular with the revised positions.
