EVDS Communication 17: Update on Back Capturing on EVDS No 2

Dear Colleagues

This communication is to inform you of recent changes to some EVDS user profiles.

Update

1. If you have a vaccinator account, you can back capture. You do not need a separate back capturing account. However, when back capturing, you must be careful to click the back capturing button on EVDS, so you capture the correct details on the system.
2. If you have a back capturing account, you can back capture.
3. The system has changed so that you no longer can have **both** a back capturing account and a vaccinator account. You can have one or the other.

Most common problem with back capturing

The most common errors that occur with back capturing are that the back capturer does not capture the correct date, time, vaccination site and name of vaccinator. This occurs because the person doing the back capturing does not click the **back capturing button on EVDS**. In this communication, we will show how to prevent this error.

How to make sure I back capture correctly- quick guide

1. When back capturing, remember that you are entering the record of a vaccination that has occurred in the past. You will therefore have to enter the vaccination date, vaccination time, vaccination site and the name of the vaccinator who actually did the vaccination. As a start, you will need a fully completed vaccination form.
2. When back capturing, it is critical to click the back capturing button on EVDS. If you do not click the back capturing button, and you are a vaccinator, the system will capture the date and time of the vaccination in real time, and will capture you as the vaccinator

3. Using the back capturing button

This button can be found on the EVDS page just before you enter information on the health background of the patient.

If you click the button, you will see the fields open up and you will be able to see the fields for date of the vaccination, time of vaccination and the name of the vaccinator.
