DEPARTMENT OF ENVIRONMENTAL AFFAIRS AND DEVELOPMENT PLANNING**WESTERN CAPE LAND USE PLANNING ACT, 2014 (ACT 3 OF 2014)****EXEMPTION FROM PROVISIONS OF ACT: MATZIKAMA MUNICIPALITY**

I, Anton Wilhelm Bredell, Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape, under section 60(1)(b) of the Western Cape Land Use Planning Act, 2014 (Act 3 of 2014)(the Act), exempt Matzikama Municipality from the provisions of sections 43, 44, 45 and 47 of the Act, in respect of the intended land use applications for rezoning, subdivision and departures on Erven 4576 and 4865, Vredendal.

Under section 60(6) of the Act I impose the condition that except for references to the Act instead of the Land Use Planning Ordinance, 1985 (Ordinance 15 of 1985)—

- (a) the original 2011 applications may not be amended; and
- (b) the original 2012 decisions by the Municipality may not be amended,

- (b) die oorspronklike 2012-besluite deur die Munisipaliteit nie gewysig mag word nie,
