INVITATION FOR PUBLIC COMMENT: DRAFT SANDVELD ENVIRONMENTAL
MANAGEMENT FRAMEWORK STANDARD, 2024**

The Provincial Minister of Local Government, Environmental Affairs and Development Planning in the Western Cape (the Provincial Minister), in terms of section 24(10)(a)(i), read together with section 24(10)(c)(i) and (d)(i) of the National Environmental Management Act, 1998 (Act 107 of 1998) (the Act)—

- (a) has started the process of developing the Draft Sandveld Environmental Management Framework Standard (the Draft Standard) and invites members of the public to comment on this Draft Standard; and
- (b) gives notice of the intention to adopt the Draft Standard once developed and invites members of the public to comment on the intention to adopt this Draft Standard.

The Sandveld Environmental Management Framework (the Framework) was adopted by the Provincial Minister in *Provincial Gazette* 8105 dated 7 June 2019 as a shared vision of sustainable agriculture within the geographical area of the Sandveld Environmental Management Framework (the geographical area), as indicated on the map set out in Schedule 1 as “Sandveld” and “Agter Cederberg”. The Framework introduces the concept of farm-level planning, which is intended to be implemented through the Sandveld Environmental Management Framework Standard.

The Draft Standard identifies measures for the management and mitigation of environmental impacts associated with the cultivation of land in the geographical area indicated on the map, and it establishes the processes and procedures for listed activities which pertain to the clearance of indigenous vegetation to be excluded from the requirement to obtain environmental authorisation. The Draft Standard furthermore provides for procedures and criteria to be used by the competent authority for the monitoring of excluded activities.

Compliance with the approved Sandveld Environmental Management Framework Standard will exclude, in terms of section 24(2)(d) of the Act, the following activities from the requirement to obtain an environmental authorisation from the competent authority prior to the start of any such activity in the geographical area:

- (a) Activity 27 of the Environmental Impact Assessment Regulations Listing Notice 1 of 2014 published under Government Notice R983 in *Government Gazette* 38282 dated 4 December 2014;
- (b) Activity 15 of the Environmental Impact Assessment Regulations Listing Notice 2 of 2014 published under Government Notice R984 in *Government Gazette* 38282 dated 4 December 2014; and
- (c) Activity 12(i) of the Environmental Impact Assessment Regulations Listing Notice 3 of 2014 published under Government Notice R985 in *Government Gazette* 38282 dated 4 December 2014.

The Draft Standard supports the environmental rights of people in the geographical area to an environment that is not harmful to their health and well-being, and to have the environment protected. The Draft Standard contains measures that will prevent pollution and ecological degradation, promote conservation, and secure the sustainable development and use of natural resources in the geographical area while promoting justifiable economic and social development.

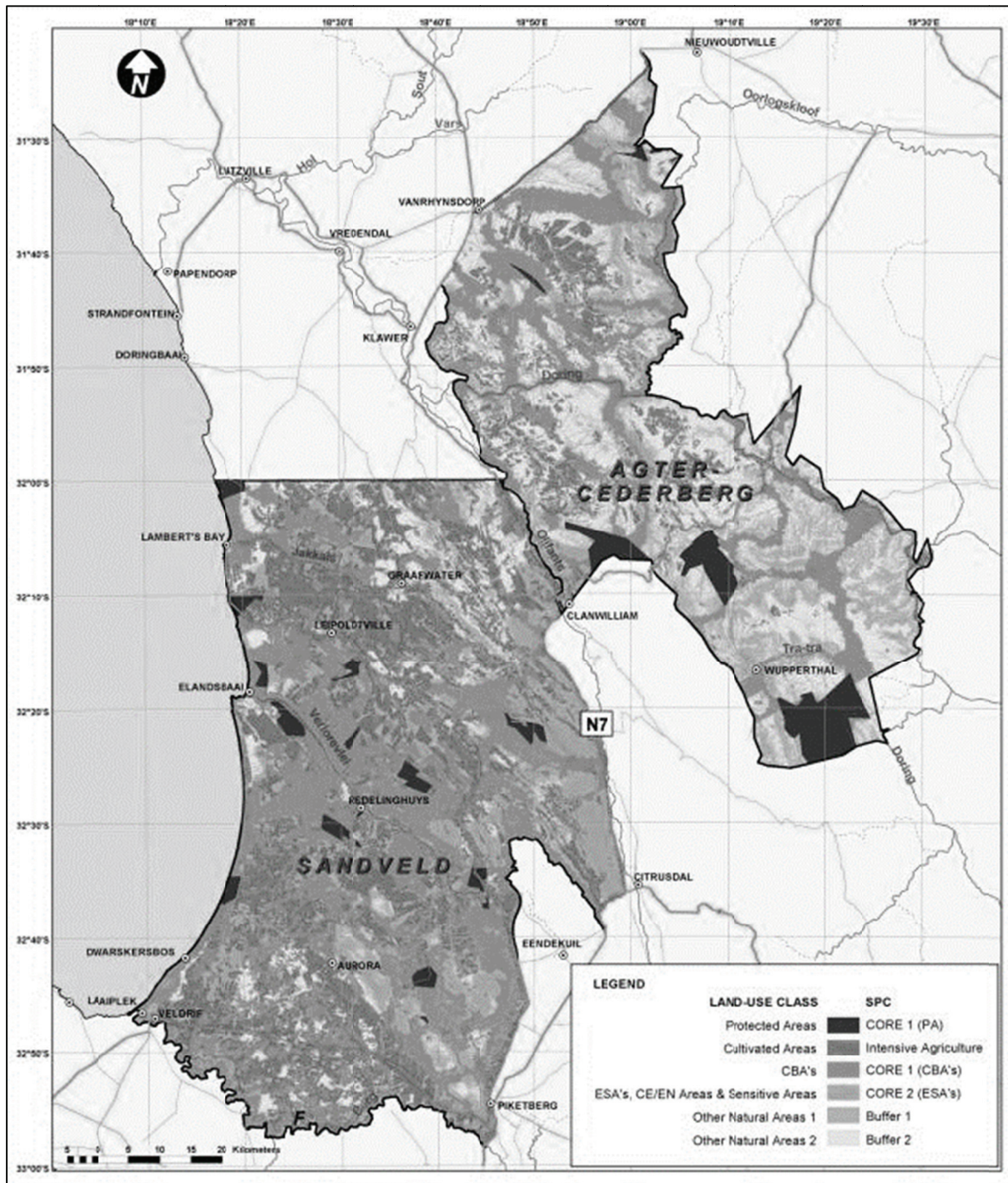

Die Provinsiale Minister van Plaaslike Regering, Omgewingsake en Ontwikkelingsbeplanning in die Wes-Kaap (die Provinsiale Minister), ingevolge artikel 24(10)(a)(i), saamgelees met artikel 24(10)(c)(i) en (d)(i) van die Wet op Nasionale Omgewingsbestuur, 1998 (Wet 107 van 1998) (die Wet)—

- (a) het begin met die proses om die Konsepstandaard vir die “Sandveld Environmental Management Framework” (die Konsepstandaard) te ontwikkel en nooi lede van die publiek om op hierdie Konsepstandaard kommentaar te lewer; en
- (b) gee kennis van die voorneme om die Konsepstandaard aan te neem sodra dit ontwikkel is en nooi lede van die publiek om kommentaar te lewer op die voorneme om hierdie Konsepstandaard aan te neem.

Die “Sandveld Environmental Management Framework” (die Raamwerk) is deur die Provinsiale Minister in *Provinsiale Koerant* 8105 gedateer 7 Junie 2019 aangeneem as ’n gedeelde visie vir volhoubare landbou binne die geografiese gebied van die “Sandveld Environmental Management Framework” (die geografiese gebied), soos aangedui op die kaart uiteengesit in Bylae 1 as “Sandveld” en “Agter Cederberg”. Die Raamwerk stel die idee van beplanning op plaasvlak bekend, wat bedoel is om deur die “Sandveld Environmental Management Framework Standard” geïmplementeer te word.

Die Konsepstandaard identifiseer maatreëls vir die bestuur en versagting van omgewingsimpakte wat verbind word met die bewerking van grond in die geografiese gebied op die kaart aangedui, en dit stel die prosesse en prosedures vir gelyste aktiwiteite in werking wat betrekking het op die opruiming van inheemse plantegroei wat uitgesluit moet word van die vereiste om omgewingsmagtiging te verkry. Die Konsepstandaard maak verder voorsiening vir prosedures en kriteria wat deur die bevoegde owerheid gebruik moet word vir die monitering van uitgeslote aktiwiteite.

Voldoening aan die goedgekeurde “Sandveld Environmental Management Framework Standard” sal, ingevolge artikel 24(2)(d) van die Wet, die volgende aktiwiteite uitsluit van die vereiste om ’n omgewingsmagtiging van die bevoegde owerheid te verkry voor die aanvang van enige sodanige aktiwiteit in die geografiese gebied:

- (a) Aktiwiteit 27 van die “Environmental Impact Assessment Regulations Listing Notice 1 of 2014” gepubliseer onder Goewermentskennisgewing R983 in *Staatskoerant* 38282 gedateer 4 Desember 2014;
- (b) Aktiwiteit 15 van die “Environmental Impact Assessment Regulations Listing Notice 2 of 2014” gepubliseer onder Goewermentskennisgewing R984 in *Staatskoerant* 38282 gedateer 4 Desember 2014; en
- (c) Aktiwiteit 12(i) van die “Environmental Impact Assessment Regulations Listing Notice 3 of 2014” gepubliseer onder Goewermentskennisgewing R985 in *Staatskoerant* 38282 gedateer 4 Desember 2014.

Die Konsepstandaard ondersteun die omgewingsregte van mense in die geografiese gebied tot ’n omgewing wat nie skadelik vir hul gesondheid en welsyn is nie, en om die omgewing te beskerm. Die Konsepstandaard bevat maatreëls wat besoedeling en ekologiese agteruitgang sal voorkom, bewaring sal

bevorder, en die volhoubare ontwikkeling en gebruik van natuurlike hulpbronne in die geografiese gebied sal verseker terwyl dit regverdigbare ekonomiese en sosiale ontwikkeling bevorder.

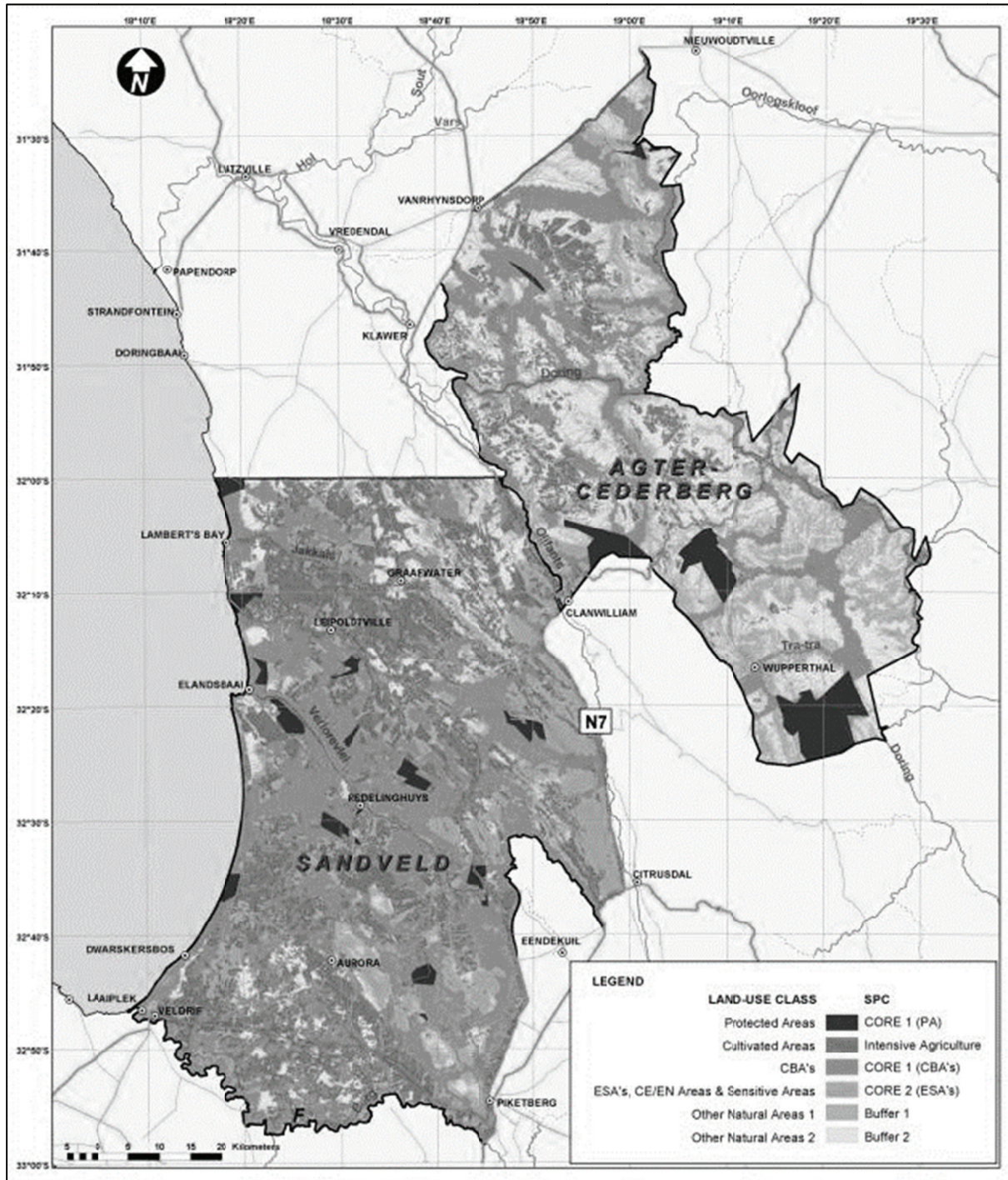

ISandveld Environmental Management Framework (iSakhelo) samkelwa nguMphathiswa wePhondo kwiGazethi yePhondo 8105 yomhla wesi7 kweyeSilimela ngo2019, njengombono ekwabelwana ngawo wezolimo oluzinzileyo kwingingqi yejiyografi yeSandveld Environmental Management Framework (ingingqi yejiyografi), njengoko kubonisiwe kwimephu echazwe kwiShedyuli 1 njenge “Sandveld” kunye ne “Agter Cederberg”. Isakhelo sazisa ngocwangciso lwefama, sijongwe ukuba siphunyezwe ng eSandveld Environmental Management Framework Standard.

UQulunqo lweMigangatho luchonga imilinganiselo yolawulo kunye nokunciphisa iimpembelelo zokusingqongileyo ezinxulumene nokulinywa komhlaba kwindawo yejiyografi eboniswe kwimephu kwaye imisela iinkqubo kunye nemigaqo yemisebenzi edwelisiweyo ephathelele ekususweni kwezityalo zemveli, ukuba ingabandakanywa imfuneko yokufumana ugunyaziso lokusingqongileyo.
