SECTION 108(2) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996**

I, Alan Richard Winde, under section 108(2) of the Constitution of the Republic of South Africa, 1996, read with section 18 of the Electoral Act, 1998 (Act 73 of 1998), and after consultation with the Electoral Commission, call for an election of the Provincial Parliament of the Western Cape and set 29 May 2024 as the voting day.
