DEPARTMENT OF POLICE OVERSIGHT AND COMMUNITY SAFETY**WESTERN CAPE COMMUNITY SAFETY ACT, 2013 (ACT 3 OF 2013)****INVITATION FOR NOMINATIONS: WESTERN CAPE PROVINCIAL SAFETY ADVISORY COMMITTEE**

I, David Richard Coetzee, Acting Head of the Department of Police Oversight and Community Safety in the Western Cape, by virtue of the powers delegated to me by the Provincial Minister of Police Oversight and Community Safety in the Western Cape (the Provincial Minister) in terms of section 32(1) of the Western Cape Community Safety Act, 2013 (Act 3 of 2013) (the Act), and under section 26(3) of the Act, invite all interested parties to submit names of persons who in their opinion are fit and proper to be appointed as members of the Western Cape Provincial Safety Advisory Committee (the Committee) for purposes of filling four vacancies on the Committee.

1. The functions of the Committee are to advise and make recommendations to the Provincial Minister at his request, with regard to—
 - (a) the functions of the Province of the Western Cape in terms of Chapter 11 of the Constitution of the Republic of South Africa, 1996 (the Constitution), and Chapter 8 of the Constitution of the Western Cape, 1997 (Act 1 of 1998) (the Western Cape Constitution, 1997);
 - (b) strategies, policies, budgets and annual performance plans in respect of the functions in terms of Chapter 11 of the Constitution and Chapter 8 of the Western Cape Constitution, 1997;
 - (c) regulations in terms of the Act that may be necessary; or
 - (d) any other matter arising from the application of the Act.
2. The Committee must consist of—
 - (a) a representative of the business community;
 - (b) a member of the judiciary, a member of the Cape Bar or an attorney who, in terms of the Legal Practice Act, 2014 (Act 28 of 2014), has been admitted and enrolled as such by the Western Cape Provincial Council contemplated in section 23(1) of that Act;
 - (c) a senior member of an academic institution with experience in the field of criminology;
 - (d) a representative from a non-governmental organisation involved in policing or related areas; and
 - (e) the Head of Department: Police Oversight and Community Safety (as an *ex officio* member).
3. Nominations are sought for the appointment of members in the aforementioned categories listed in paragraph 2(a) to (d).
4. The successful candidates will be appointed for a three-year term, which may be renewed once.
5. Remuneration will be paid in accordance with the 2022 Remuneration Levels: Service Benefit Packages for Office-Bearers of Certain Statutory and Other Institutions, issued by the Chief Director: Public Entities Governance Unit (National Treasury) with effect from 1 April 2022, which rates are reviewed from time to time.
6. All nominations must be submitted in writing in the form of a signed letter indicating the following:
 - (a) the contact details of the nominator and his or her interest in policing or community safety;
 - (b) the name, surname and contact details of the candidate and a motivation for the nomination of the candidate.
7. All nominations must be accompanied by the following:
 - (a) the signed letter referred to in paragraph 6;
 - (b) a detailed *curriculum vitae* of the candidate together with certified copies of his or her qualifications;
 - (c) the identity document or passport of the candidate; and
 - (d) a letter signed by the candidate accepting his or her nomination.

UITNODIGING VIR BENOEMINGS: WES-KAAPSE PROVINSIALE VEILIGHEIDSADVIESKOMITEE

Ek, David Richard Coetzee, Waarnemende Hoof van die Departement van Polisietoesig en Gemeenskapsveiligheid in die Wes-Kaap, uit hoofde van die bevoegdhede wat aan my gedelegeer is deur die Provinciale Minister van Polisietoesig en Gemeenskapsveiligheid in die Wes-Kaap (die Provinciale Minister) ingevolge artikel 32(1) van die Wes-Kaapse Wet op Gemeenskapsveiligheid, 2013 (Wet 3 van 2013) (die Wet), en kragtens artikel 26(3) van die Wet, nooi alle belanghebbende partye uit om die name van persone voor te lê wat na hul mening gepas en bevoeg is om as lede van die Wes-Kaapse Provinciale Veiligheidsadvieskomitee (die Komitee) aangestel te word, met die doel om vier vakaturen in die Komitee te vul.

1. Die funksies van die Komitee is om die Provinciale Minister te adviseer en aan hom voorstelle te doen op sy versoek, oor—
 - (a) die funksies van die Provincie Wes-Kaap ingevolge Hoofstuk 11 van die Grondwet van die Republiek van Suid-Afrika, 1996 (die Grondwet), en Hoofstuk 8 van die Grondwet van die Wes-Kaap, 1997 (Wet 1 van 1998) (die Wes-Kaapse Grondwet, 1997);
 - (b) strategieë, beleid, begrotings en jaarlikse prestasieplanne met betrekking tot die funksies ingevolge Hoofstuk 11 van die Grondwet en Hoofstuk 8 van die Wes-Kaapse Grondwet, 1997;
 - (c) regulasies ingevolge die Wet soos benodig; of
 - (d) enige ander aangeleentheid wat uit die toepassing van die Wet voortspruit.
2. Die Komitee moet bestaan uit—
 - (a) 'n verteenwoordiger van die sakegemeenskap;
 - (b) 'n lid van die regbank, 'n lid van die Kaapse Balie of 'n prokureur wat, ingevolge die *Legal Practice Act, 2014* (Wet 28 van 2014), toegelaat en as sodanig ingeskryf is by die Wes-Kaapse Provinciale Raad beoog in artikel 23(1) van daardie Wet;
 - (c) 'n senior lid van 'n akademiese instelling met ervaring op die gebied van kriminologie;
 - (d) 'n verteenwoordiger van 'n nieregeringsorganisasie wat by polisiëring of verwante gebiede betrokke is; en
 - (e) die Departementshoof: Polisietoesig en Gemeenskapsveiligheid (as 'n *ex officio*-lid).
3. Benoemings word verlang vir die aanstelling van lede uit die bogenoemde kategorieë in paragraaf 2(a) tot (d) gelys.
4. Die suksesvolle kandidate sal vir 'n termyn van drie jaar aangestel word, wat eenmalig hernu kan word.
5. Vergoeding sal betaal word ooreenkomsdig die *2022 Remuneration Levels: Service Benefit Packages for Office-Bearers of Certain Statutory and Other Institutions*, uitgerek deur die Hoofdirekteur: Eenheid vir Bestuurstoesig oor Openbare Entiteite (Nasionale Tesourie) met ingang van 1 April 2022, welke tariewe van tyd tot tyd hersien word.
