The consolidated statement reflects the financial performance of municipalities as at the end of the third quarter (ending 31 March 2024) of the 2023/24 municipal financial year.

The Provincial Treasury uses National Treasury's Database as the primary source for the information reported in this publication. Although every effort has been made to compile a reliable set of numbers, the quality and completeness of the information is affected by the credibility of reports submitted by municipalities.

**SUMMARY ON THE STATE OF LOCAL GOVERNMENT REVENUE AND EXPENDITURE: THIRD QUARTER CONSOLIDATED STATEMENT FOR THE PERIOD 1 JANUARY 2024 - 31 MARCH 2024**

---

**BACKGROUND**

Section 71(7) of the Municipal Finance Management Act (MFMA) requires that the Provincial Treasury must, within 30 days after the end of each quarter, make public as may be prescribed, a consolidated statement in the prescribed format on the state of municipalities' budgets per municipality and per municipal entity.

This publication forms part of the In-Year Management, Monitoring and Reporting System for Local Government which enables the Provincial Treasury (PT) to exercise oversight over municipalities in the Western Cape. It provides a high-level review of the implementation of municipal budgets for the third quarter, ending 31 March 2024.

**DATA USED**

National Treasury's Local Government Database is the primary data source used for this publication. The quality of the report is subject to the credibility of the municipal Standard Chart of Accounts (mSCOA) data string information submitted by the tenth working day of each month and is compromised when municipalities fail to submit all the required data strings.

Some anomalies were noted in the submissions made by municipalities which have a significant impact on the credibility of the financial information reported for the period ending 31 March 2024. Discrepancies on key indicators were observed on the negative cash and cash equivalent budgets and year-to-date actuals reported by some municipalities as well as misalignments on capital funding and expenditure.

To assist municipalities to submit credible mSCOA data strings, PT has institutionalised an mSCOA segments use analysis tool which is shared with municipalities on a monthly basis. PT also has technical engagements with municipalities to discuss mSCOA findings. Municipalities are required to develop an action plan indicating specific timelines to resolve issues identified so that PT can keep track of the progress made by municipalities monthly.

Despite the challenges, Western Cape municipalities are committed to improving the quality of information with support from the National and Provincial Treasuries.

The data presented in this gazette provides a summary of the budget implementation performance against key indicators for all municipalities in the province. The data used was extracted on 16 April 2024 and detailed information for each municipality is available to the public in the section 71 files published at [mfma.treasury.gov.za](http://mfma.treasury.gov.za).

## AGGREGATED TRENDS

1. In aggregate, Western Cape municipalities spent R64.43 billion or 60.9 per cent of the total adjusted expenditure budget of R105.79 billion by the end of the third quarter on 31 March 2024 (actual operating expenditure accounted for R56.84 billion and actual capital expenditure for R7.59 billion).
2. In respect of revenue, aggregate billing and other revenue amounted to R73.00 billion or 69.7 per cent of the total adjusted revenue budget of R104.70 billion (actual operating revenue accounted for R65.42 billion and actual funds utilised to fund the capital budget amounted to R7.58 billion).
3. Service charges and property rates are the largest revenue sources, contributing 47.5 per cent and 18.3 per cent, respectively, towards the total adjusted operating revenue budget of R87.89 billion. This is consistent with past trends.
4. For the quarter under review property rates underperformed by R95.48 million or 0.8 per cent against the Year-to-Date (YTD) budget of R12.36 billion. An underperformance from service charges of R429.13 million or 1.4 per cent against the YTD budget is noted. This is mainly due to underperformances of R484.7 million (2.22 per cent) and R32.95 million (1.7 per cent) in respect of Service charges – Water as well as Service charges - Waste Management, respectively. Service charges and property rates revenue represent billed revenue and not actual revenue collected.
5. To date municipalities spent R56.84 billion or 64.0 per cent of their aggregated adjusted operating expenditure budget of R88.87 billion. Employee related costs is the highest cost driver, amounting to R19.13 billion or 33.7 per cent of the total operating expenditure to date, followed by Inventory consumed and bulk purchases of R17.80 billion or 31.3 per cent of the total operating expenditure to date and other expenditure amounting to R14.49 billion or 25.5 per cent of total operating expenditure.
6. Aggregated operating expenditure underperformed by R2.00 billion or 3.65 per cent against the year-to-date operating budget as at the end of March 2024. A year-on-year comparison indicates an increase in operating expenditure of R4.36 million or 8.3 per cent.
7. As at the end of March 2024, an aggregated operating surplus of R8.58 billion against an adjusted operating deficit budget of R981.28 million was reported. The surplus may be due to some municipalities reducing in-year spending in line with their limited available revenue and cash. However, it was also noted that several municipalities are not fully reporting on their non-cash items (debt impairment and depreciation), this significantly understates the operating expenditure reported to date and results in an exaggerated operating surplus.
8. Municipalities in the Western Cape spent R7.59 billion or 44.9 per cent of their aggregated R16.92 billion adjusted capital budget to date. Spending is slow with an underperformance of R2.47 billion or 24.6 per cent in the current year when compared to the budgeted year-to-date performance. However, a year-on-year comparison shows capital spending by municipalities is 20.3 per cent higher than at the same point last year.
9. The City of Cape Town reported capital spending of R5.21 billion (46.0 per cent of the adjusted budget) which is an underperformance of 15.9 per cent against the year-to-date budget. Secondary cities (Drakenstein, George and Stellenbosch municipalities) reported aggregated capital expenditure performance of R962.39 million or 42.6 per cent against their combined adjusted capital budget of R1.99 billion. Local municipalities' capital spending amounted to R1.34 billion or 43.7 per cent against their aggregated capital budget of R3.06 billion. Municipalities' capital spending is largely dependent on the timeous planning and completion of supply chain processes such as advertisement of bids and evaluating and awarding contracts to successful bidders.

10. In aggregate, Western Cape municipalities planned to fund 67.6 per cent of their total capital investment from own funding, an increase from the 64.9 per cent budgeted in the prior year. This comprises of internally generated funds (40.5 per cent) and borrowings (27.1 per cent).
11. Capital spending funded from borrowings to-date amounted to R1.6 billion or 35.1 per cent of the budgeted borrowings of R4.56 billion. For the quarter under review capital funding from borrowings reduced by R535.68 million or 11.8 per cent of which the City Cape Town reported a negative amount of R816 million against its borrowing funding source. The Metro reported (FMR: M07-2023/24) that savings on expenditure items will be set aside to reduce borrowing and to fund the Metro's capital programme.
12. Capital spending funded from transfers to-date amounted to R2.77 billion or 50.9 per cent of the budgeted amount of R5.44 billion (Q3; R892.29 million or 16.4 per cent). Internally generated funds utilised to-date amounted to R3.21 billion or 47.9 per cent of the approved budget of R6.81 billion (Q3; R2.11 billion or 30.9 per cent).
13. The aggregate municipal consumer debtors balance as at 31 March 2024 amounted to R15.95 billion. The bulk of the outstanding debt is owed by households, which account for R11.34 billion or 71.1 per cent of the total outstanding debt.
14. Debtors older than 90 days amounted to R10.61 billion or 66.5 per cent of the total outstanding debtors of R15.95 billion. This includes historic debt that has accumulated over an extended period, interest on arrears and other recoveries.
15. Quarter-on-quarter outstanding debtors have increased by R333.73 million or 2.1 per cent, from the R15.61 billion reported at the end of the December 2023. Debtors over 90 days increased by R270.81 million or 2.6 per cent during the third quarter.
16. In aggregate, Western Cape municipalities reported outstanding creditors of R685.16 million as at 31 March 2024. Outstanding creditors older than 30 days amounted to R332.76 million or 48.6 per cent of the total outstanding creditors. Total outstanding creditors have increased by R113.78 million or 19.9 per cent when compared to the outstanding creditors of R571.38 million reported as at the end of December 2023. Municipalities cited various reasons for payments that are owed for more than 30 days.
17. Four (4) municipalities in the Western Cape collectively owe Eskom an amount of R283.75 million in outstanding payments overdue for more than 30 days. Each of the four (4) municipalities have been approved to participate in the Municipal Debt Relief programme. All four (4) municipalities are adhering to the terms and conditions of the debt relief programme.
18. The total cash and cash equivalents reported by municipalities as at the end of the third quarter amounted to R29.59 billion. However, this amount is overstated and does not align with balances in the Municipal Budget and Reporting Regulations (MBRR) schedules reported to municipal councils.
19. Provincial Treasury will continue to provide support to municipalities including guidance and support with mSCOA implementation, budget verifications, annual budget and in-year monitoring workshops, capacity building training initiatives, quarterly Chief Financial Officers' and Municipal Accountants Fora as well as facilitating the reduction of government debt owed to municipalities in conjunction with various government departments.
