Additional funding requirements for community-based day care programmes (centre- based – including special care centres) rendering service to persons with severe and profound intellectual disability: to comply with Mental Health Care Act:

- Facility to be Licensed with the Department of Health (Mental Health Care Act No 17 of 2002 & its regulations)
- Special Care Centres for children with severe and profound intellectual disability: adherence to the
 Department of Education Learning Programme for Children with Severe to Profound Intellectual
 Disability or a similar programme as approved by the Department of Basic Education (guiding
 support and educational stimulation programmes.)
