## FUNDING APPLICATION PROCESS FOR THE 2024 -27 FUNDING CYCLE

The Department herewith wishes to inform social sector organisations of a comprehensive NPO Call for Proposals for the 3-year funding cycle commencing in 2024/25.

The Call for Proposals will be advertised on social media and the DSD website. Applications will open on 31 July 2023 and close on 15 September 2023.

The assessment of the NPOs for funding eligibility will commence from October 2023 and conclude by March 2024. NPO Applications are to be submitted to the DSD either via:

Eligibility for consideration for funding is subject to a completed application form and all applicable documentation having been submitted timeously. Incomplete applications may not qualify to be funded as from the 1 April 2024. Late applications will **not** be accepted.

Only services as specified by the Programme Specifications will be considered for funding and **NO** other services. It is important to note that the Programme Specifications for Older Persons excludes residential, independent and assisted living facilities, while the Programme Specifications for Persons with Disabilities excludes residential facilities and protective workshops. A separate call for proposals for residential, independent and assisted living facilities for Older Persons, and residential facilities and protective workshops Persons with Disabilities only will be issued in the latter half of 2024.
