# PILOT WORKSHOP ON STANDARD OPERATING PROCEDURES (SOPs) FOR EXPENDITURE MANAGEMENT & SESSION ON GRAP STANDARDS: 25 JULY 2013 IN GEORGE

#### 1. PURPOSE

1.1 The purpose of this circular is to invite municipalities to attend a workshop session on the Standard Operating Procedures for the Expenditure Cycle, on the selected Standards of GRAP and the recently issued Exposure Drafts. The session will take place on Thursday, 25 July 2013 in George.

#### 2. MOTIVATION

- 2.1 According to the Municipal Governance Review and Outlook (MGRO) action plans submitted by municipalities, the Local Government Accounting will provide the following transversal support amongst others:
  - a) Roll out Standard Operating Procedures for Expenditure Management
  - b) Specific GRAP training on the new standards.
- 2.2 The main aim of the session is to build capacity within municipalities and achieving improvements on the audit outcomes. The session will cover the following:
  - a) Standard Operating Procedures on the Expenditure Cycle;
  - b) Discussions on the overview of the new six GRAP Standards that are effective; and
  - c) The post implementation review of GRAP 16: Investment Property & GRAP 17: Property, Plant & Equipment (ED 110) and also on Revenue from non-exchange transaction (Taxes & Transfers) (ED 113) for coordinating comments of the Province to the Accounting Standards Board.
