## JOINT MUNICIPAL CHIEF FINANCIAL OFFICERS' AND MUNICIPAL MANAGERS' FORUM LEKGOTLA – 5 & 6 DECEMBER 2013

- 1. The annual Chief Financial Officers' Forum Lekgotla is scheduled for Thursday and Friday, 5 and 6 December 2013.
- 2. It is the intention that the upcoming Lekgotla be held as a joint Lekgotla to be attended by both Chief Financial Officers and Municipal Managers. You are welcome to be accompanied by two additional municipal officials. The Lekgotla will be held in George.
- 3. This year marks a decade of MFMA's implementation and related reforms, hence the focus of the discussions will be to reflect on the 10 years of MFMA implementation and to discuss the way forward inclusive of the areas of reform which still needs to be implemented. Issues emanating from the MM Forum will also feature on the agenda.
- 4. The topics on the agenda for the two days will include, amongst others, the following:

  - k) 2012/13 MFMA Audit Outcomes Where are we still falling short?
  - SALGA programme of action for the 2013/14 financial year;
