3. REQUEST VERIFICATION OF MEMBER



- 3.3 In the event that a representative was previously nominated, but changes have occurred within the municipality, kindly confirm the details of the new member and nominate a proxy on the annexed nomination forms.
- 3.4 In an event where there is no ERM activity or no official appointed to drive and facilitate the ERM process, it remains the MM's responsibility in terms of the MFMA. S6(1)(c)(i)

3.5 Please note that the onus is on the Municipal Manager to inform the relevant official at the Provincial Treasury of any changes in membership.
