NOMINATION OF MUNICIPAL GOVERNANCE REVIEW & OUTLOOK (MGRO) CHAMPIONS

1. PURPOSE

The purpose of this circular is to request municipalities to nominate MGRO champions to enable improved co-ordination of the MGRO process.

2. BACKGROUND OR MGRO PROCESS

The MGR&O process aims to improve and promote clean governance within municipalities as well as actively assisting municipalities in raising the level of their governance. This process supports the Provincial Strategic Objective 12 - "Being the best run regional government within the world" and the national initiative Operation Clean Audit – realising clean audit outcomes by 2014.

The MGR&O process was initiated in September 2012 with the trilateral engagements on a district level between the Executive Management of Municipalities, PT and DLG inclusive of the MEC for Finance, Economic Development and Tourism.

3. OBJECTIVES OF MGRO

- To assist municipalities with the implementation of good governance principles, strengthen financial management and encourage accountability that will enable them to obtain improved audit outcomes ;
- Drive a systematic approach to combine the intelligence of PT and DLG that will assist municipalities to attain not only a level 3 rating but also beyond (levels 4 – 6);
- To promote accountability of all stakeholders to improve the state of governance within the local government sphere.

4. ROLES & RESPONSIBILITIES OF MGRO CHAMPIONS

The MGRO co-ordinator will be responsible for the following:

- Being the liaison between the municipality and Provincial Treasury

- Co-ordinating the MGRO process within the municipality
- Co-ordinating the MGAP completion and submission thereof to Provincial Treasury

It is envisaged that the MGRO co-ordinator will work closely with the Provincial Treasury MGRO co-ordinators. Furthermore, this will enable effective communication, monitoring and assistance in respect of the MGRO process.

5. REQUEST

The Municipal Manager of each municipality is required to nominate an MGRO champion who will be the contact person for all MGRO related issues.

Nominations should be submitted using the attached form and should reach the Provincial Treasury by no later than 25 April 2014.
