MUNICIPAL CHIEF FINANCIAL OFFICERS' FORUM – 5 AND 6 JUNE 2014

1. This circular serves to confirm that the Municipal Chief Financial Officers' Forum will take place on **Thursday and Friday, 5th and 6th of June 2014** at the **Lord Milner Hotel, MATJIESFONTEIN, Central Karoo District**.
2. Provincial Treasury notes that June is the last month of the municipal financial year and that one of the final steps in the accounting cycle is the preparation of the financial statements.
3. For the financial officer of every municipality around South Africa, the preparation and submission of accurate annual financial statements that comply with Generally Recognised Accounting Practices or GRAP is of paramount importance.
4. Consequently, the theme for the CFO Forum discussions will be the “ **Preparation of GRAP Compliant Annual Financial Statements & the adequacy of Audit files to improve 2013 Audit Results**”
5. To this end, representatives from the Accounting Standards Board, Office of the Auditor-General South Africa, Department of Human Settlements, National and Provincial Treasury will amongst others, address the following matters:
