## APPROVAL AND SUBMISSION OF 2014/15 ANNUAL BUDGETS, IDPs AND SDBIPS

## 1. **PURPOSE**

1.1 The purpose of this circular is to outline the procedures regarding the submission of the adopted annual budgets & supporting documents, IDPs and approved Service Delivery Budget and Implementation Plans (SDBIPs).

## 2. **DISCUSSION**

# **Approval of the Annual Budgets**

- 2.1 Section 24(1) of the MFMA prescribes that the Municipal Council of a municipality must at least 30 days (i.e. by 30 May) before the start of the budget year consider the approval of the annual budget.
- 2.2 Furthermore, section 24(2) of the MFMA further states that an annual budget:
  - a) Must be approved before the start of the budget year;
  - b) Is approved by the adoption by the council resolution referred to in section 17(3)(a)(i); and
  - c) Must be approved together with the adoption of resolutions as may be necessary
    - i. Imposing any municipal tax for the budget year;
    - ii. Setting any tariffs for the budget year;
    - iii. Approving measurable performance objectives for revenue from each source and for each vote in the budget;
    - iv. Approving any changes to the municipality's integrated development plan; and
    - v. Approving any changes to the municipality's budget related policies.
- 2.3 Section 24(3) of the MFMA, read together with regulation 20(1) of the Municipal Budget and Reporting Regulations (MBRR), requires that the approved annual budget must be submitted within ten working days after the council has approved the annual budget. So in the event that council approves the annual budget on 30 May 2014, the date for such submission is Friday, 13 June 2014, otherwise an earlier date applies if the budget will be adopted before 31 May 2014.

- 2.4 In terms of the MFMA Circular No 72, municipal managers are required to submit:
  - The budget documentation as set out in Schedule A of the Municipal Budget and Reporting Regulations, including main Tables (A1 – A10) and all the supporting tables (SA1 –SA37) and prescribed minimum narrative information in both printed and electronic format; and
  - The applicable council resolution(s).
- 2.5 In terms of the Regulation 31 of the MBRR, annual budget and supporting documentation must be covered by a quality certificate as outlined in the MBRR.
- 2.6 Furthermore, MFMA Circular 72 requires that the hardcopies of the budget documents must be formally stamped and signed by the secretariat responsible for ensuring accurate records of council decisions.

# Failure to approve budget before the start of budget year

2.7 In the unlikely event that an annual budget is not approved, section 25 of the MFMA states that: (1) If the municipality failed to approve an annual budget, including revenue-raising measures necessary to give effect to the budget, the council must reconsider the budget and again vote on the budget, or an amended version thereof within seven (7) days of the council meeting that failed to approve the budget. (2) The process provided for in subsection (1) must be repeated until a budget, including revenue-raising measures necessary to give effect to budget, is approved. (3) If a municipality has not approved an annual budget, including revenue-raising measures necessary to give effect to the budget, by the first day of the budget year, the mayor must immediately comply with section 55 of the MFMA.

# Municipal Service Delivery and Budget Implementation Plans (SDBIPs) and Performance Agreements

- 2.8 In terms of section 69(3) of the MFMA that the accounting officer must no later than 14 days after the approval of an annual budget submit to the mayor
  - a) A draft service delivery and budget implementation plan for the budget year; and
  - b) Drafts of the annual performance agreements as required in terms of section 57(1)(b) of the Municipal Systems Act (MSA) for the municipal manager and all senior managers.
- 2.9 In terms of section 53(1)(a)(iii) of the MFMA the mayor of a municipality must approve, the municipality's Service Delivery and Budget Implementation Plan (SDBIP) within 28 days after the approval of the budget.

- 2.10 Subsequently, the accounting officer must submit the approved SDBIP to the national and provincial treasury within ten working days after approval of the SDBIP by the mayor.
- 2.11 Section 53(3) of the MFMA further states that the mayor must ensure:
  - a) The revenue and expenditure projections for each month and the service delivery targets and performance indicators for each quarter, as set out in the service delivery and budget implementation plan, are made in public no later than 14 days after the approval of the service delivery and budget implementation plan; and
  - b) That the performance agreements of the municipal manager, senior managers and any other categories of officials as may be prescribed, are made public no later than 14 days after the approval of the municipality's service delivery and budget implementation plan. Copies of such performance agreements must be submitted to the council and the MEC for local government in the province.

# Certification that budget is correctly captured.

- 2.12 In terms of paragraph 7.2 of MFMA Circular 72, the National Treasury, requests the accounting officer of each municipality in terms of the section 74 of the MFMA to provide a signed certificate by no later than 15 July 2014 certifying that:
  - (1) The adopted annual budget has been captured on the municipality's financial system, and that there is complete agreement between the budget on the system and the budget adopted by council;
  - (2) That the adopted annual budget on the municipality's financial system is locked; and
  - (3) That the municipality has in place controls to ensure that the budget captured on the financial system can only be changed in accordance with:
    - a. a virement authorised by the municipal manager, or duly delegate official, in terms of a council approved virements policy; and
    - b. an Adjustments Budget approved by council.
