# PROVINCIAL TREASURY MUNICIPAL FINANCIAL MANAGEMENT INTERNS WORKSHOP – 26 JUNE 2014

#### 1. PURPOSE

This circular aims to invite municipal financial management interns and mentors to attend the Western Cape Provincial Treasury Financial Management Internship workshop which will be held on the 26 June 2014 at Cape Winelands District Municipality's Council Chambers, 50 Trappe Street, Worcester.

## 2. BACKGROUND

The Municipal Financial Management Internship Programme (MFMIP) was introduced to assist municipalities to build their financial management capacity to implement the Municipal Financial Management Act, (No 56 of 2003) [MFMA] and municipal financial reforms. The NT MFMIP is an organised professional training and work experience programme with the goal of providing high quality training and practical exposure to interns in all aspects of municipal finance. It provides a platform for graduates to receive on the job training in terms of local government finance.

In terms of section 5(3) of the MFMA Provincial Treasuries are responsible to assist, guide and monitor municipalities in terms of compliance with the MFMA and its related regulations.

Section 34 of the MFMA further requires PT to monitor, assist and support municipalities in building the capacity of municipalities for effective, efficient and transparent financial management. The monitoring and support provided by PT to municipalities regarding the successful implementation of the NT MFMIP is directly linked to the above requirement as it responds to the current lack of financial management capacity and the future demands within the local government environment.

#### 3. OBJECTIVE OF THE WORKSHOP

The objectives of the workshop are the following:

 National Treasury will be conducting a validation exercise; to validate the physical existence of current interns that are enrolled in the Municipal Financial Management Internship Programme funded by National Treasury; and  Provincial Treasury will be providing an overview of the functions within the Municipal Budget and Treasury Office; with the view of equipping interns with the knowledge to gain relevant practical and theoretical exposure required to successfully operate within a specialised functional area.
