MUNICIPAL REGULATIONS ON STANDARD CHART OF ACCOUNTS (SCOA): MFMA SCOA HELPDESK

1. PURPOSE

- 1.1 The purpose of this circular is to notify municipalities that Provincial Treasury has designed a HelpDesk, which will be technically focused on all issues related to SCOA;
- 1.2 This process is automated by using the following email address: <u>MFMA.SCOAHelpDesk@westerncape.gov.za</u>

2. BACKGROUND

- 2.1 Section 216 of the Constitution of the Republic of South Africa, 1996, provides that national legislation must prescribe measures to ensure transparency and expenditure control in each sphere of government by introducing generally recognised accounting practice, uniform expenditure classifications and uniform treasury norms and standards.
- 2.2 Government Gazette No. 36806 (Notice 892 of 2013) on the draft regulations on SCOA was published for public comment on 3 September 2013 for a period of 90 days. The Minister of Finance has, in terms of section 168 of the Local Government: Municipal Finance Management Act, 2003 (Act No.56 of 2003), and acting with the concurrence of the Minister of Cooperative Governance and Traditional Affairs gazetted Municipal Regulation on SCOA into effect on 22 April 2014.
- 2.3 Designing the HelpDesk will assist Provincial Treasury in executing its mandate of monitoring, support to ensure successful implementation of the Municipal Regulations on Standard Chart of Accounts in the Province.

3. OBJECTIVE

3.1 The objective of the HelpDesk is to:

create a single window of communicating issues related to SCOA

implementation in the Province;

gather views /problems on SCOA for discussion in various forums in the

Province;

track capabilities of incoming problems;

keep organized, track records of all issues that are submitted by municipalities

for escalation to National Treasury;

distribute feedback and conduct follow up on issues raised.
