REPAYMENT OF UNSPENT PROVINCIAL ALLOCATIONS FOR 2012/13 AND PRIOR FINANCIAL YEARS

1. Purpose

The purpose of this circular is to request municipalities to repay any unspent provincial allocations to the respective Western Cape Government departments from the 2012/13 financial year and prior years that are currently in municipal bank accounts.

2. Background

This process is informed by the provincial rollover process which entailed the verification and reconciliation of provincial grants as per Treasury Circular Mun 28 of 2014 and as informed by the rollover application letters received from the Municipalities.

Provincial Treasury has become aware of the unspent provincial funds in municipalities through this process which was implemented for the first time in 2013/14 financial year. The application letters to rollover funding to 2014/15 financial year that were received in August 2014 contained amounts which were previously rolled over to 2013/14 financial year.

It is a principle or norm, as captured in Treasury Mun 28 of 2014, that funds can only be rolled over to the next year and if the municipality fails to spend, then funds must revert back to the Provincial Revenue Fund.

This process is implemented to promote proper planning and implementation of projects or activities that are funded through the provincial allocations.

3. Repayment method

The capital portion of the unspent funds must be deposited to a bank account of the transferring department by **30 September 2014** and a proof of payment must be sent to MFMA.MFMA@westerncape.gov.za for the attention of Mr ZSS Zonyane.

The email must clearly indicate the department to which the repayment was made, the amount that was repaid, the year in which the allocation was gazetted and what was the gazetted purpose of the allocation.

The bank account details of the transferring departments are clearly contained in the table on page 4 and municipalities are advised to use the correct bank details for respective Western Cape Government department and the municipal code as a reference.

Note that all the accounts are with Nedbank and the branch code is the same for all the departments.

4. Reallocation of the funding

Municipalities that have projects to which the funds are committed must contact the respective Western Cape Government departments and copy Provincial Treasury and motivate that the funds be reallocated and gazetted for the purpose of completing such projects. This must be done by **3 October 2014** to ensure that internal processes within the Western Cape Government are conducted timeously to ensure reallocation and gazetting during the upcoming 2014 provincial adjustment budget process.
