The National Treasury via its appointed service providers are embarking on a one day information sharing session to "Demystify mSCOA". These sessions will be held one per province and the provisional dates are stated in the table below.

The intention of the one day session is to provide information on the following topics.

- Introduction to the standard chart of accounts (mSCOA)
- Understanding key definitions and the accountability reforms.
- Classify, analyse and report on the economic classification using all segments of the Standard Chart of Accounts (mSCOA).
- How mSCOA will change the financial reporting requirements of municipalities.

The last topic will be discussed very briefly as this component is still being discussed and not yet finalised.

The target audience is restricted to the following per municipality and municipal entity.

- Accounting officer
- Chief Financial Officer
- Director Technical/Infrastructure Services

The Provincial Treasuries must also nominate a group of individuals that will become the mSCOA support team to assist municipalities in implementing mSCOA to 30 June 2017 and beyond. These nominated individuals limited to 5 per treasury must also attend the one day information sessions.

The Provincial Treasuries must appoint a mSCOA coordinator that will liaise with the mSCOA project office at the National Treasury to arrange the logistics relating to the one day information sessions.
