TRAINING ON THE MANAGEMENT AND REPORTING OF PREDETERMINED OBJECTIVES FOR MUNICIPAL OFFICIALS: 13 – 14 FEBRUARY 2014, RUSLAMERE HOTEL, SPA & CONFERENCE CENTRE, DURBANVILLE

PURPOSE

1.1 The purpose of this Circular is to invite municipalities to a training session on the management and reporting of Predetermined Objectives which will be held from 13 – 14 February 2013 at Ruslamere Hotel, Spa & Conference Centre, Durbanville (directions attached).

2. MOTIVATION

- 2.1 The Western Cape Provincial Treasury in partnership with the Provincial Department of Local Government implemented the first phase of training to municipal officials on the management and reporting of predetermined objectives during March 2013. This training covered the following:
 - The principle foundations for performance information;
 - Performance management in practice;
 - Legislative and official guidance;
 - Predetermined objectives in context; and
 - The Auditing of predetermined objectives.
- 2.2 The next phase aims to build further capacity amongst municipal officials to:
 - Implement performance management principles outlined in the National Treasury's Framework for Managing Programme Performance Information;
 - Improve integrated structures, systems and processes required to manage performance information;
 - Promote the effective application of performance information; and
 - Raise awareness and understanding of the optimal utilisation of performance information to ultimately improve service delivery.

3. LOGISTICAL ARRANGEMENTS

3.1 The training programme will be covered over the following two days upon which certificates will be issued on completion of all the requirements of the training:


