## **SCHEDULE OF DATES FOR THE CHIEF RISK OFFICER (CRO) AND CHIEF AUDIT EXECUTIVE (CAE) FORUMS**

### **1. PURPOSE**

This circular serves as advance notice of the provisional dates for the aforementioned forums, year ending March 2016.

### **2. BACKGROUND**

The forums were established to provide centres for learning, the agenda guided by the most prevalent issues burdening these disciplines.

The forums have evolved considerably since inception and have become the voice of the local government CROs and CAEs at professional bodies such as the Institute of Internal Auditors South Africa, Public Sector Audit Committee Forum, Integrated Risk Management South Africa, National Forums, etc.

### **3. OBJECTIVES**

The objectives of the forums are to:

- Enhance the achievement of the objectives of the:
  - i. Municipal Finance Management Act, 2003 ( Act 56 of 2003)
  - ii. National Treasury MFMA Circular No.65
  - iii. Internal Audit Framework (National Treasury)
  - iv. National Treasury Risk Management Framework
- Build institutional capacity and relationships;
- Facilitate and encourage knowledge sharing;
- Establish formal and informal communication channels and support networks;
- Consult on strategies and priorities;
- Promote sound financial governance and accountability;
- Improve planning, co-ordination and prevent duplication of effort; and
- Adoption of best practices.

### **4. FREQUENCY OF THE FORUMS**

Provincial Treasury has heeded the requests for less travel in light of capacity constraints and will therefore reduce the number of forums from quarterly to biannually. This, without limiting the value-add of the forums.

The quarterly forums will be alternated with district CRO and CAE engagements, co-ordinated by the district disciplines and supported by the Provincial Treasury.
