# MINUTES OF THE MUNICIPAL CHIEF FINANCIAL OFFICERS' FORUM

# 7 & 8 DECEMBER 2015, SIMOLA HOTEL COUNTRY CLUB & SPA KNYSNA

THEME: "INTEGRATED APPROACH TO IMPROVE FINANCIAL GOVERNANCE FOR INCLUSIVE GROWTH"

# 1. **OPENING AND WELCOME**

The Chairperson, Mr H Malila, opened the meeting and welcomed all present.

# 2. ATTENDANCE AND APOLOGIES

An attendance register is attached as Annexure A. Apologies received from municipalities were recorded and is listed in Annexure A.

### 3. OPENING ADDRESS BY THE MAYOR: KNYSNA

Ms G Wolmarans welcomed all attendees on behalf of the Knysna Council to the 2015 CFO Lekgotla in the Eden District. She indicated that Knysna Municipality has received their third consecutive clean audit, which was driven by accountability and good governance. She was pleased that Knysna was used to hold the CFO Lekgotla.

#### 4. APPROVAL OF THE AGENDA

No additional items were added to the draft agenda which was circulated.

#### 5. **KEY NOTE ADDRESS**

Post 10 Year Implementation of the MFMA, paradigm shift required to improve financial governance to enable inclusive growth – Central role of the CFO.

Mr TV Pillay started his presentation with a Motivation and Innovation video clip after which a presentation was done.

## **Questions/Comments**

No comments or questions were raised.

#### 6. **NEW MATTERS**

- 6.1 <u>Panel Discussion</u> **Towards integrated planning and budgeting to maximise the** creation of public value and inclusive growth
  - Setting the scene: Economic Outlook, fiscal context and implications for government finances, particular for municipalities

Ms M Korsten indicated how we create public value and what we do in the finance space translate to inclusive growth. The session will focus on the practical questions that have been raised and the practical solutions to the conditions that we are facing. She introduced the panel members with the topics that they will be discussing. She did a presentation on the Economic and Fiscal Outlook.

- WCG Game Changer: Energy Security
  - Dr H Fast did a presentation on Preparing for Solar PV: Energy Security Game Changer in concert with GreenCape.
- Public Value Creation: Integrated planning and Budgeting as a tool to enhance public value creation
  - Prof E Schwella did a presentation on Public Value.
- New economic efficiencies/Old economy relationship Public Transport Innovations to improve public value creation, integrated communities
  - Ms C Bunding-Venter did a presentation on The Transport and Public Value: GO GEORGE.
- SCM and LED reform agenda in municipalities in the Western Cape: Using SCM as a strategic tool to enhance LED
  - Mr R Moolman did a presentation on Using SCM as a strategic tool to enhance LED.

#### **Questions/Comments**

Ms S de Visser stated that Ms C Bunding-Venter mentioned in her presentation that they are unlocking properties in George and activating the economic development through it, as to how George is hoping to activate that economic development not just for the bigger business but target the smaller businesses in that context. The second question relates to the energy game changer, particular to municipalities outside the metro. Dr Fast mentioned that the City is looking at the gas economy through direct purchases from IPP (Independent Power Producer). If you a local municipality and you have a big wind farm in your area that is all not locked in your WIG program, how would they go about if they are interested to become off takers directly from those farms, and from a supply chain sense, what kind of obstacles will they face?

Mr Z Zonyane would like to see in future for engagements held in Western Cape.

Mr J Carstens stated that they are supposed to encourage people to install solar panels as a game changer. There should be a cost reflective time of use tariff and a basic charge. The presentation indicates that all customers should pay a network service or demand charge. His concern is that the poorest of the poor cannot afford to put on solar panels. What is the view of this on the long term?

Ms S Reyneke-Naude stated that they foresee challenges with NERSA where municipalities align their tariff structure accordingly.

# Responses

Ms C Bunding-Venter stated that the majority of the transfer nodes are along the integration corridors closer to communities. In the CBD, the transport system in the investment is changing the discussion between tenant and the landlord. When they talk about regeneration issues, they often have the discussion with the property owner and not with the tenant. Through collaborate discussions are they able to unlock real opportunities for small businesses and just changing the dynamics.

Ms M Korsten responded to the question regarding the comment about the Western Cape specific risks are noted.

Dr H Fast responded to the question if municipalities can get into the IPP space. Can municipalities start generating beyond 1 mW or can they buy from the wind farm or solar farm close to them? The answer is that at the moment the regulatory framework says that if municipalities want to do that they have to ask the national minister of energy for permission. There are power constraints in SA that we are going to head for a crisis in the next year or two for a wide variety of reasons. The issue in terms of procurement is too asked for permission to directly buy from the IPP who is on the national program. Once you do have that permission then you have to make it worthwhile in terms of the transmission costs that will be incurred. Then

they have to go on public procurement process but in some cases the field would be seriously narrowed.

Jack from GreenCape responded that the issues with ministerial determination, they will be looking at the Wheeling guidelines. So where the municipality is not purchasing energy directly but allowing the big distributing power plant to be wheeling across their networks and how the tariffs and regulations work for that space. With regards to Drakenstein Municipality around indigents customers – they are working very closely with CSIR and Stellenbosch University to look at how they ensure equity in the PV space. This is looking at how they attach a certain tariff to customers that could afford to install PV but have chosen not to ensure there is a ring-fence pool of money coming into the municipality that can be used to support your indigents customers with continues subsidisation in terms of electrification. With regard to the question of NERSA, is that they have been working closely with NERSA.

# 6.2 <u>Panel Discussion</u> – Accountability & Capacity Building – Moving to action

- Setting the scene Integrated Financial and Non-Financial Risk Management:
   Linking risk management to planning, performance measurement and reporting.
  - Mr B Vink introduced the panel members and opened the discussion with the presentation of Integration of Performance and Risk Management. He emphasised that risk management is management responsibility.
- Internal Audit & Audit Committee A strategic partner of the CFO lever for change
  - Ms Z Abrams did a presentation.
- Understanding Combined Assurance in partnering for a sustainable municipality
   Mr K Jacoby did presentation on Combined Assurance: The next level of Governance Maturity?

#### **Questions/Comments**

Mr F Sabbat indicated that the smaller municipalities' first line of defence on the combined assurance is PT due to lack of resources at their municipality. They indicated that they will wait for the City of Cape Town to finalise their framework and edit it to make it a policy of their own.

Mr Z Hoosain stated that combined assurance has two angles to it. The one is about the increase of scope of coverage which was addressed. The other is particular for the smaller municipalities because of tighter budgetary environment.

He wanted to know from the City's perspective if they had observed any correlation of getting combined assurance at reduction cost?

A comment was raised that the biggest problem is the role clarity of the internal auditors.

# Responses

Mr K Jacoby stated that the City has not implemented it yet. The biggest contributing of measure is that stage of the assessment and the only contribution that he found from it some risks that they have not been mapped. So he cannot say that the City has lessons learned from it, because they have not implemented it. If it is that combined assurance does not add to the effectiveness of an organisation, then it must be kicked out.

Ms Z Abrams indicated that in terms of role clarity should be stated in the TOR.

- 6.3 2014/15 Preliminary Municipal Audit outcomes and Governance challenges identified through 2014/15 Audit
  - Mrs S Adams did a presentation on the Audit outcomes of local government.

# **Questions/Comments**

Mr F Sabbat commented that Beaufort West Municipality will ensure that the basic controls are in place. There have also been a lot of keen vacancies in the past 2 to 3 years that has not been filled. They will also make the list of internal controls less.

Mrs S Adams responded that getting the basic controls in place is the first step in the right direction.

- 6.4 <u>Panel Discussion -</u> Institutionalising the improvement of corporate and financial management practices, and capacity building
  - Setting the scene Improving efficient, effective & responsive local governance through reforms
    - Ms E Barnard introduced the panel members after which a presentation was done.
  - mSCOA regulations: Business process enhancement to drive council performance and financial sustainability
    - Ms S Koekemoer did a presentation on mSCOA.
  - mSCOA: "A Western Cape Approach"
    - Ms M Fortuin did a presentation did a presentation on mSCOA: support provided by WCPT.

#### **Questions/Comments**

A question was raised as to how many non-pilots municipalities in the WC will go live on the 1 July 2016?

When NT classifies a municipality's system ready is it just the ledger or the whole system?

A statement was raised that they don't agree with NT that the vendor readiness lies with the municipality.

Another statement that was raised is to get seamless integration within the municipal financial systems will course a lot of problems going forward.

A comment was raised regarding attending all steercom meetings both from NT and PT which was not happening. It seems that Mossel Bay is left on their own without the support. Mossel Bay was approach by Mr C Stroud from NT to be an early adopter. He attended the first meeting and promised the municipality that they will get a project manager from PT. Until today there has been no project manager provided. The municipality didn't get any funding and they request Province to fulfil their obligation.

#### Response

Ms S Koekemoer stated that i.t.o. assessing vendors for readiness is that NT is not responsible to assess compliance with any regulation. They have been working very closely with the vendors. The challenge is that the vendor might have the functionality available to assist to become SCOA compliant. That is not to say that the municipality bought that from the vendor and is on the latest version. A minimum specification was given from NT. Compliance with the regulations will be done by the AGSA after the 1 July 2017. SCOA readiness will be handled by the technical team.

Ms M Fortuin responded that they don't know how many early adopters there will be.

Ms E Barnard requested that the issue of Mossel Bay be sorted after the meeting with Mr Z Hoosain, Mr H Malila and Mr A Hardien.

Mr Z Hoosain stated that the issues being raised were quite serious. He received feedback from Ms M Fortuin after the ICF i.t.o. the sudden hand over to the PT. His understanding to this was that they were responsible to manage change. He needs to get clarity on this and will take all the decisions on the issues mentioned. He requested that the municipalities write to NT with all their issues. The TCF is on the

22 January 2016 and he will request an update. The issue w.r.t. Mossel Bay will be taken up with the PT staff after the meeting.

  - 5. The staff, are they our greatest asset or liability?
  - 6. What are staff exposed to?

# Streamlining WCG municipal activities: Towards an integrated approach

Mr Z Hoosain did a presentation on Integrated Policy, Planning and Budgeting Process.

#### **Questions/Comments**

A question was raised on the early adoption of the municipal budgets considering that the elections and the LG MTEC engagements with municipalities prior to the budget approval. How is this taking into consideration?

#### Response

Mr H Malila stated that early adoption process is taking into account and has not yet been finalised. The same process as the 2011 election will be used, depending on when the municipalities table their budgets.

# 6.5 <u>Panel Discussion</u> - **LG Financial Sustainability – Weathering the storms**

- Setting the scene: Fiscal Policy, Economic Growth and Expenditure composition
   Mr M Sigabi introduced the panel members after which a presentation was done on high level.
- Revenue enhancement initiatives: Establishing Service Levels with the community
  - Mr K Kritzinger did a presentation.
- Public Value Creation through Stakeholder Management
   Mr K Haarhof did a presentation.
- Expenditure Efficiency management
   Mr F Lötter did a presentation.
- State of Local Government Finances Strategies to address municipal performance failures (NT)
  - Mr T Phogole did a presentation on State of Local Government and Financial Sustainability.

#### **Questions/Comments**

Mr J Carsten stated that he liked the idea of not allowing payments through the sundry payment system but through order system but follow the route through the SCM system. If they issue an order to ESKOM or the AGSA, do they treat it as a deviation or do they just pay it?

Mr F Bergh stated that the long term financial plan goes around good financial controls and does not sometimes look at service delivery. He warned to keep a good balance between the two.

Mr S Vorster commented on the presentation from NT:

- 1. Creditors' payment period on which the statistics was noted and that this ratio will never be 30 days. In Saldanha Bay Municipality the ratio is 70 days but it does not mean that the municipality is paying within 30 days.
- 2. The free cash flow was interesting and would like the breakdown on how the amounts were calculated.

#### Response

Mr F Lötter responded that i.t.o. the bulk payments and statutory payments, the SCM regulations allow for this not to be part of a supplier chain process. There is no deviation. With respect to the long term financial plan, revisions are done. In the first year of implementation, they had to deviate from the tariff increases that were prescribed within the plan.

Mr T Phogole stated that the free cash flow is more proper to work on the end of the financial year and that they don't have the actual breakdown. It will take into account current liabilities, unspent conditional grants, rehabilitation of landfill sites (look at years), and leave pay.

Mr M Sigabi thanked the panel members for their contribution and closed the discussion.

# 6.6 Panel Discussion - Towards improving municipal Infrastructure spending

- Setting the scene: To facilitate and streamline of infrastructure delivery in municipalities, within the desired timeframes and to excellent quality standards
  - Ms J Gantana introduced the panel members. She did a presentation "Towards Improving Municipal Infrastructure Spending".
- Infrastructure Investment: CIDB requirements
  - Mr A Jordaan did a presentation on "Improving municipal Infrastructure spending".
- National Treasury: Roll out strategy Municipal Infrastructure delivery
   Mr G Cronje did a presentation.

#### **Questions/Comments**

Mr J Carstens wanted to know if the engineers can't give him a planning document with design specifications with cost estimates, then he cannot put it in the budget. So how is he going to budget for the next 5 years? If this is going to be regulations, then this will stop service delivery in local government.

# Response

Mr G Cronje responded that if you start to do the planning, you have an initiation report on the project. Before you put it on the infrastructure plan, you must have a proper excepted strategic brief or feasibility study before approval. This will not stop service delivery.

Ms J Gantana thanked the panel members for their assistance.
