PROGRESS ON KEY SUPPLY CHAIN MANAGEMENT (SCM) ISSUES EMANATING FROM NATIONAL TREASURY'S SCM REFORM PROCESS

BROAD BASED BLACK ECONOMIC EMPOWERMENT (B-BBEE) REQUIREMENTS IN RESPECT OF ACCEPTING "SWORN AFFIDAVITS" FOR EXEMPTED MICRO ENTERPRISES (EMEs) AND QUALIFYING SMALL ENTERPRISES (QSEs)

PURPOSE

- 1.1 The purpose of this Circular is to provide:
 - a) Progress on the following key supply chain management issues emanating from National Treasury's supply chain management reform process:
 - i. Central Supplier Database;
 - ii. eTender Publication Portal: and
 - iii. National Treasury Contracts and Central Procurement Initiatives.
 - b) Feedback in respect of the B-BBEE requirements of accepting "sworn affidavits" for B-BBEE credentials for EMEs and QSEs.

2. CENTRAL SUPPLIER DATABASE

- 2.1 The National Treasury has indicated via Circular 3 of 2015/16 that the utilisation of the Central Supplier Database will become compulsory with effect from 1 April 2016.
- 2.2 Permission has been granted by the National Treasury for the Western Cape Government (WCG) to run the Western Cape Supplier Database (WCSD) concurrently with the Central Supplier Database (CSD) provided that:
 - a) The CSD is the master of supplier information and such information cannot be modified by the WCSD; and
 - b) Suppliers registered on the CSD, should not be excluded or disadvantaged in anyway by the existence of the WCSD.
- 2.3 The Provincial Treasury has however identified various challenges on the CSD which has been raised with the National Treasury and awaits feedback on these challenges.
- 2.4 In respect of the compulsory utilisation of the CSD with effect from 1 April 2016, given the challenges experienced to date and the permission granted by National Treasury, the WCSD will augment and be used to support the CSD. Provincial Treasury will issue a process map for SCM requirements for uniformity on practice within the WCG.

3. eTENDER PUBLICATION PORTAL

- 3.1 The National Treasury has indicated in the update to the SCM review that the utilisation of the eTender publication portal for advertising bids and publishing awards will be compulsory with effect from 1 April 2016. The current National Treasury Regulations, 2005 (NTRs) prescribes that bids must be advertised and awards published in the Government Tender Bulletin (GTB).
- 3.2 Institutions are required to advertise bids and publish awards thereof in both the GTB and the e-Tender publication portal until such time that the NTRs are revised as we are obliged to comply with the regulations up until the requirement has been repealed. Advertisements in newspapers was, and is an optional requirement as the need dictates.

4. NATIONAL TRANSVERSAL CONTRACTS AND CENTRAL PROCUREMENT INITIATIVES

4.1 National Treasury has communicated via a media statement dated 7 March 2016,

that as from 1 April 2016, the participation of government in existing and new

transversal contracts will be compulsory. National Treasury Circular 3 of 2016, "Utilization of Transversal Contracts" dated 02 March 2016, was issued aimed at

informing institutions of the transitional arrangements after the promulgation of the

revised Treasury Regulations. To date these regulations have not been issued nor

Gazetted.

4.2 Accounting Officers and Accounting Authorities are to note that the MEC for

Finance has addressed the WCG's concerns to the National Minister of Finance on the constitutionality and legality of issuing this requirement and has requested that

the National Minister reconsider his decision. We are awaiting a response in this

regard.

4.3 Given that the current regulatory requirements have not been amended nor

repealed the current regulation 16A6.5 issued in terms of Government Gazette

27388 dated March 2005, applies. Hence the status quo remains until further notice.

4.4 The Provincial Treasury has in the meantime provided institutions (via SCM heads)

with National Treasury Circulars 1, 2 and 3 of 2016 in respect of the National Travel

and Accommodation Project, National Mobile Communications Project and Utilisation of Transversal Contracts respectively.

5. B- BBEE REQUIREMENTS IN RESPECT OF ACCEPTING "SWORN AFFIDAVITS" FOR B-BBEE

CREDENTIALS FOR EMES AND QSES

5.1 The legal position has been finalised and presented to the Premier of the Western Cape who has made a decision on the issue. The decision will firstly be brought

before Cabinet for notification, after which a Provincial Treasury Circular will be

issued to all institutions communicating the said decision.

6. REQUEST

6.1 Accounting Officers and Accounting Authorities are requested to note and adhere

to the content of this circular.
