INFRASTRUCTURE REPORTING MODEL (IRM) REQUIREMENTS FOR 2016/17

THE DEPUTY DIRECTOR GENERAL: CORPORATE ASSURANCE, DEPARTMENT OF THE PREMIER (MS H ROBSON)

1. **PURPOSE**

The purpose of this Circular is to inform all Accounting Officers, Chief Executive Officers and Infrastructure delivery officials of the requirements in terms of section 13(1)(e) of the Division of Revenue Act (DoRA).

2. BACKGROUND AND DELIBERATION

The Division of Revenue Act (DoRA) requires infrastructure departments to provide reports on aggregate spending on infrastructure, based on the prescribed format. The Web-based Infrastructure Reporting Model (IRM) has been prescribed in terms of section 13(1)(e) of DoRA. Respective provincial departments have the responsibility to report progress on infrastructure projects to the Provincial Treasury which will monitor progress and verify data quality.

The provincial department's responsibility regarding the IRM is to record all ongoing projects and to capture all new infrastructure projects at the beginning of each financial year onto a Planning IRM with projected expenditure for the financial year.

National Treasury has transferred all the ongoing infrastructure projects of 2015/16 financial year per department to the 2016/17 financial year, except projects at final completion and terminated projects. A budget will have to be allocated for the project to be regarded as active, whilst those projects with future year budgets will fall under inactive projects. Projects without budget allocation will not accepted by the system.

On the 3rd March 2016, the B5 Tables (summary of details of expenditure for infrastructure by category) per department has been tabled and submitted to National Treasury. These B5 tables will form the source document to capture project budgets.

Provincial Treasury has provided training to assist departmental officials responsible for capturing project data and budgets to ensure data integrity for the 2016/17 Planning IRM (attendance lists attached).

3. **ACTIONS REQUIRED**

It would be appreciated if:

- 3.1 The Circular is brought to the attention of all staff involved in the planning and delivery of public infrastructure/construction procurement.
- 3.2 Departmental officials commence with the capturing of budget allocations as per 2016/17 Planning IRM and ensure alignment with respective department's 2016/17 B.5 Tables (Summary of details of expenditure for infrastructure by category).
- 3.3 The remaining fields of the 2016/17 planning IRM, such as location, project status, details, contractors, timeframes, project cost, project estimates, cash flows in-year, BAS, etc. are updated after the 31st March 2016. (To note that BAS training will be provided on **7 April 2016** by National Treasury to ensure that the capturing of project segments are aligned to Standard Chartered Of Accounts (SCOA).

- 3.4 The first draft 2016/17 Planning IRM and the final 2016/17 Planning IRM duly signed off by the Head of Department or delegate with a rank not lower than Chief Director must be submitted on or before the 15th April and 22nd April 2016 respectively to the following infrastructure analysts:
