## RE: PT: LOCAL GOVERNMENT SUPPLY CHAIN MANAGEMENT INDABA, 2017: SUSTAINABLE PROCUREMENT: 20 - 21 NOVEMBER 2017 WITHIN THE CAPE WINELANDS DISTRICT MUNICIPALITIES

#### 1. PURPOSE

- To inform all municipalities and municipal entities of the 3<sup>rd</sup> Annual Local Government SCM Indaba, 2017: Sustainable Procurement that is scheduled to take place dated, 20 - 21 November 2017.
- 1.2 The SCM Indaba will be hosted in collaboration with the Department of Economic Development and Tourism (DEDAT) and the Cape Winelands District municipalities.
- 1.3 To request all municipalities and municipal entities to submit at least five (5) representatives, preferably the SCM Manager, SCM Practitioner and the LED Manager, LED Practitioner and or the CFO, who will attend the Indaba.
- 1.4 The purpose is also to acknowledge the efforts of the Cape Winelands District Municipality, Drakenstein Municipality, Stellenbosch Municipality and the other municipalities within the Cape Winelands District in terms of the logistical arrangements as well as hosting the SCM Indaba: Sustainable Procurement in Rawsonville at the ATKV Goudini Spa Resort.
- 1.5 Where the senior official is unable to attend the Indaba the municipality and municipal entity may nominate a representative, preferably an official of the municipality's Supply Chain Management unit and a representative from the LED Department.

1.6 The purpose of the SCM Indaba: Sustainable Procurement is to provide a shared platform for discussion and learning on the utilisation of procurement as a catalyst for local economic growth and inclusive economic development.

#### 2. BACKGROUND

- 2.1 In terms of section 5(3) of the MFMA (Act 56 of 2003), a provincial treasury may assist municipalities and municipal entities in building their capacity for efficient, effective and transparent financial management.
- 2.2 The Directorate Local Government Supply Chain Management facilitates this mandate by providing assistance and guidance to municipalities and municipal entities on the regulatory framework that governs Supply Chain Management.
- 2.3 Emanating from the quarterly SCM Forums, the Local Government Supply Chain Management (LG SCM) Directorate, realised that there is a need in the SCM fraternity to create a professional environment to build institutional capacity for efficient, effective and transparent financial management as well as the promotion of the professional development of SCM Practitioners.
- 2.4 This communique serves as an official confirmation of support of the objectives of the SCM Indaba: Sustainable Procurement with specific emphasis on the promotion of a culture of excellence and efficiency, with the alignment of the local economic development department with the supply chain management department in terms of the procuring of goods and services.
- 2.5 However, not only has the demand been for SCM to become more efficient, effective and transparent, but there are increasing questions of the role of institutional procurement both public and private sector as a means of contributing to economic growth and inclusive economic development.
- 2.6 Procurement as a catalyst for economic grow and development is a relatively new concept and for many intuitions a daunting task given the increasing imposition of new compliance requirements. The successful combination of compliance and contribution to economic growth and development still remains a maze for many institutions.
- 2.7 The reality we now face is that procurement as means of economic growth and development has become an imperative. The recent (and ongoing) surge of legislation and regulations (e.g. local content requirements) is a clear indication of the seriousness of government in enforcing its will to ensure economic transformation.

2.8 The 2017 SCM Indaba: Sustainable Procurement, themed "<u>Utilising procurement as</u> <u>a strategic enabler to enhance local economic development</u>", seeks then to create an opportunity for role-players to not only engage on the key challenges of this new imperative, but more importantly, to share experiences which contribute to us all working together to uplift and grow our communities.

## 3. OBJECTIVES TO BE ACHIEVED THROUGH THE PROCUREMENT INDABA

- 3.1 To provide a socio-economic context for the imperative of the utilisation of procurement as a significant contributor to inclusive economic growth and development.
- 3.2 To share and deliberate the overcoming of challenges posed by compliance requirements in tandem with increasing calls for procurement as means to economic transformation.
- 3.3 To share experiences and exchange learnings both from an institutional and business perspective on the successful implementation of projects and programmes that showcase procurement as a contributor to economic well-being.
