STANDARD CHART OF ACCOUNTS: INFORMATION SESSIONS TO BE HELD DURING JUNE 2013

Purpose

To inform departments of the planned information sessions to be held on the eight segment Standard Chart of Accounts (SCOA) for officials responsible for processing payments on the financial systems, namely BAS and LOGIS.

Background

SCOA version four was introduced by the National Treasury with effect from 1 April 2013. Official SCOA training is normally presented by PALAMA, in partnership with the National Treasury. However, National Treasury has not yet finalised the training material on the latest changes to SCOA and as a result no training is scheduled for the near future.

In the absence of any training by National Treasury on SCOA, the Provincial Treasury has planned SCOA information sessions throughout the province to inform officials of the general principles of the SCOA and the latest changes to SCOA (Version 4).

Information sessions

The information sessions will provide departmental financial management staff with a basic understanding of the SCOA. The information sessions are aimed mainly at officials responsible for processing payments on BAS and LOGIS (clerks and their supervisors).

The roll out plan will firstly deal with Head Office staff and thereafter the various regions. Smaller sessions are preferred to a single session with the intention of providing these sessions closer to places of employment. The attached **Annexure A** provides a programme of these sessions and officials should decide on the most convenient session to attend. There is no need for nominations or bookings, however officials should make the necessary internal arrangements with their supervisors.

Head office officials who cannot attend their Department session are welcome to attend sessions at other venues. Sessions at the other venues are open to officials of all departments.

Please note: The duration of sessions are limited to three hours and candidates should cater for their own refreshment needs.
