PUBLIC PRIVATE PARTNERSHIP FOUNDATION TRAINING FOR 2013/14 FINANCIAL YEAR

1. PURPOSE

The purpose of this circular is to share information about National Treasury's upcoming Public Private Partnership Foundation Training and to encourage provincial departments to attend the PPP Foundation Training on the dates mentioned below.

2. BACKGROUND

National Treasury is hosting quarterly PPP Foundation Training courses to capacitate and train both government and private sector officials on Public Private Partnerships. The outline of the foundation training is as follows:

- The PPP regulatory framework;
- PPP Contact Management;
- Project finance structures;
- Project documentation;
- Risk transfer in PPPs;
- Risk mitigation;
- BBBEE for PPPs; and
- Role of Transaction Advisors in PPPs.

3. DISCUSSION

Provincial departments willing to initiate and register PPP projects are encouraged to attend National Treasury's quarterly PPP Foundation Training, on the following dates during the 2013/14 financial year:

Should a delegate register for the PPP-training and not attend or do not assign someone else to attend on his/her behalf, or do not cancel at least 72 hours before hand, he/she will be charged for the cost incurred by the National Treasury's PPP Unit.


