# COMMISSION OF INQUIRY INTO REMUNERATION AND CONDITIONS OF SERVICE IN PUBLIC SERVICE AND PUBLIC ENTITIES LISTED IN SCHEDULE 3A AND 3C OF THE PUBLIC FINANCE MANAGEMENT ACT, 1999

### 1. **PURPOSE**

This serves to inform Accounting Officers regarding the establishment of the commission by the presidency in terms of the government gazette dated the 19<sup>th</sup> August 2013, with reference to the commissions' inquiry into the remuneration and condition of public entities (PFMA). In preparation for the exercise being conducted by the commission, Provincial Treasury would appreciate Accounting Officers and Chief Financial Officers to kindly provide us with the necessary information regarding their specific provincial public entities, and statutory and other institutions.

### 2. BACKGROUND

The Commission is established out of section 84(2)(f) of the Constitution of the Republic of South Africa, 1996 and has been appointed by the presidency to inspect the public entities that are listed in the Schedule 3A and 3C in terms of

Public Financial Management Act and for office-bearers of certain statutory and other institutions. The purpose is to promote uniform and transparent administrative actions in determining the remuneration levels and the commission shall inquire into, make findings, report on and make recommendations concerning the public entities.

## 3. ACTION REQUIRED

Provincial Treasury is in the process of assisting the Presidency with the necessary information and updating our database in order to ensure the required information will be readily available.
