RE-IMPLEMENTATION OF BAS/SCOA 2013/14

PURPOSE

 To inform Accounting Officers (AOs) and Chief Financial Officers (CFOs) of departments of the agreement reached with National Treasury on the implementation of the Standard Chart of Accounts (SCOA) Version 4 for the 2013/14 and 2014/15 financial years.

BACKGROUND

- Significant concerns were raised by departments on the implementation of SCOA
 Version 4 with effect from 1 April 2013. In view thereof the Provincial Treasury had
 raised these concerns in a letter to National Treasury on 19 February 2013.
- The National Treasury responded with possible options on how to deal with these concerns which were further explored at the SCOA Information Session on 28 February 2013.

OUTCOME

- 4. It was agreed at the SCOA Information Session that:
- 4.1 SCOA V3 in respect of the "inventory" item structure will replace "inventory and consumables" items on SCOA Version 4 for the Western Cape only as an interim measure for the 2013/14 financial year. "Inventory and consumables" items of V4 SCOA will be hidden for the 2013/14 financial year and will be re-activated on 1 April 2014 to allow for the Western Cape Provincial Departments to prepare for the implementation of SCOA Version 4 (inventory and consumables);
- 4.2 GG vehicle expenditure classified under "Fleet services" in SCOA Version 4, will revert back to "T&S GG vehicle without driver" as per SCOA Version 3; and
- 4.3 The 2013/14 Budgets of the Western Cape departments will be aligned to SCOA V3 in terms of points 4.1 and 4.2 above. The Provincial Treasury will be taking steps to ensure that all departments in the Province would be in a position to compile their 2014/15 budgets based on SCOA Version 4.

REQUIRED

- 5. Departments to take cognisance of the outcomes of the SCOA Information Session of 28 February 2013 and to ensure that the Budget and expenditure for inventory and GG vehicle (km tariffs and daily tariffs of pool vehicles) are dealt with accordingly for the 2013/14 financial year.
- 6. Departments to take steps in preparing for the full implementation of SCOA V4 in the 2014/15 financial year and onwards with regard to the split of inventory and consumables.
- 7. Your co-pperation in this regard will be highly appreciated.
