CASH MANAGEMENT ARRANGEMENTS – MARCH 2013

- 1. Due to the problems and challenges experienced on the current transversal systems, BAS and LOGIS, it has become necessary to accommodate a number of additional payment releases as a pro-active measure to afford departments more time to capture and authorise payments on the systems. This is aimed to complement the effective realisation of budget expenditure up to the end of the 2012/13 financial year.
- 2. This Circular serve to inform departments of the amended payment release dates for the remainder of March 2013.
- 3. The scheduled and additional payment release dates for March 2013 are reflected in Table 1.

- 4. In addition to the above arrangements, departments are also encouraged to utilise the Beneficiary Payment (BP) system on Nedbank Business over the period 26 to 28 March 2013. Departments must ensure that the Cash Management unit in the Provincial Treasury is notified of such additional payments at least two days in advance to ensure sufficient funding is made available within the limits of available cash.
- 5. Notwithstanding the above measures, departments must adhere to the Provincial Treasury's Cash Management Framework, which highlighted the importance for expenditure to remain within the available cash of the departments to the end of 31 March 2013.
- 6. It would be appreciated if these arrangements are brought to the attention of all staff dealing with cash and banking in departments.
- 7. Your co-operation in this regard would be greatly appreciated.
