Kukho izithuba ezimbini kwibhodi yolawulo (“iBhodi”) yeWCLA yabantu abahlangabezana neemfuno ezichazwe ngezantsi. Ukutyunjwa kwamagama kumenywa kubantu abanomdla ukuba batyumbwe abagqatswa abathi ngokoluvo lwabo bafanele ukonyulwa njengamalungu eBhodi.  - (i) kwiinkqubo zokuqinisekisa ukuphendula ngendlela eyiyo, ubulungisa kunye nokungafihlisi ekuqhubeni kweshishini lombutho; okanye
 - (ii) ukujongana nokulwa kweziphumo ezimbi zentlalo zokusetyenziswa gwenxa kotywala.
