RE: STATUS OF TRAINING ON SUPPLY CHAIN MANAGEMENT

1. Purpose

1.1 To provide feedback to municipalities on the status of Supply Chain Management training courses.

2. Background

- 2.1 As most of you are aware, there has been a delay in the offering of SCM training courses for municipalities since the beginning of the year. This delay was due to the following reasons:
 - (a) The transformation process that took place late last year where SAMDI was transformed into a Learning Academy.
 - (b) SAMDI was in a process of appointing an accredited service provider for SCM training.
- 2.2 An accredited service provider has since been appointed and National Treasury is awaiting the revised tariffs from SAMDI pertaining to the costs for each training course. Once the National Treasury has finalised the cost model for each training course, a training schedule will be forwarded to Provincial Treasury who in turn will disseminate such information to all municipalities.

3. Request

3.1 In the interim municipalities are requested to identify the officials that still require SCM training. This will ensure that all officials within the SCM units receive SCM training.
