# DIRECTIVE: IMPLEMENTATION FRAMEWORK FOR ALL DEPARTMENTS AND PUBLIC ENTITIES IN RESPECT OF TRAVELLING BY AIR

## Purpose

To inform accounting officers of provincial departments and accounting authorities of public entities of the limitations (for departments and public entities) that will henceforth apply in respect of all officials of both departments and public entities as well as Board members of the various public entities when making use of air travel, namely that no first class or business class air travel is allowed, be it for domestic or international travel (excluding upgrading by airlines at no additional cost to the department or public entity).

#### Discussion

- 2. As you may be aware, due to the global financial and economic crisis, recession in most of the developed world, a dramatic decline in commodity prices and cooling domestic consumption expenditure have all contributed to a decline in aggregate demand and business confidence and resultantly also a decline in forward estimates for tax revenue, i.e. for both national and provincial governments.
- 3. At the same time, the more constrained economic environment, coupled with the Provincial fiscal envelope that has been reduced and most likely will also further be reduced over the MTEF, obliged the Province to take further steps to improve efficiency and obtain value for money in public sector (departmental and public entity) spending. In this regard, the leveraging from efficiency gains throughout baselines of all departments and public entities during the 2009 budget process has somehow soften any adverse effects of the tightening fiscal envelope on key provincial and national priorities.
- 4. The Premier, in her 2009 State of the Province address, inter alia indicated that departments (and by implication also public entities) have not been using public resources to the maximum public benefit, that budgets will be fine-tuned to cut more of the remaining fat and that the new government will make sure that taxpayers are getting value for money and further that government will ensure that its assets are managed in the public interest. She concluded by indicating that the Western Cape Government will be going back to basics, applying principles of good management

- and best practice to do what is required to be done implying being efficient and implement the principles of least cost and value for money.
- 5. The Executive Council of this Province has already risen to the challenge in leading from the front in that it considered the benefits and privileges to which Members of the Executive and their families are entitled to in the execution of their duties, as contemplated in the Ministerial Handbook, with a view of curtailing certain expenditure items that do not necessarily add to the bottom line of improved service delivery.

# Actions required

6. This circular aims to provide a provincial implementation policy protocol and framework that responds to the issues and quests raised by both the Premier, the Provincial Executive Council and the National Government in curtailing expenditure. In respect of air travel, the following limitations (for departments and public entities) will henceforth apply, i.e. in respect of all officials of both departments and public entities as well as Board members of the various public entities.

#### Air Travel

- (i) No first class or business class air travel is allowed, be it for domestic or international travel (excluding upgrading by airlines at no additional cost to the department or public entity).
- 7. You are also advised that further directives and policy protocols on the limitation of certain expenditure items will be issued by the Provincial Treasury.
