1. **Purpose**

1.1 To inform the municipalities that the Provincial Treasury is in the process of rolling out the Supply Chain Management to municipalities.

2. **Background**

- 2.1 In order to ensure successful implementation of the Supply Chain Management (SCM) by the municipalities, Provincial Treasury will offer assistance and support to municipalities. In doing so Provincial Treasury is in the process of rolling-out the SCM to municipalities with the aim of fully capacitating them on SCM related issues. The roll out programme includes a 2-3 day workshops with each of the 5 districts. Training, procedural manuals and guidelines will be provided to municipalities
- 2.2 The Provincial Treasury initiative on the SCM roll-out plan will include the following phases:
 - ❖ PHASE 1: Design & Methodology Formulation
 - PHASE 2: Assessment of current levels of capacity & competency
 - ❖ PHASE 3: Design SCM Guidelines & Training Programme
 - ❖ PHASE 4: Implementation
 - Skills Enhancement
 - Knowledge Transfer
 - **Process Flow Fine Tuning**
 - ❖ PHASE 5:Review
