#### 1. Purpose

## 2. Background

- 2.1 As part of the National Treasury's roll-out strategy to implement SCM to municipalities, National Treasury will continue to provide **SCM training** for municipal officials at **operational level** during 2007/2008 financial year. National Treasury will also provide a training course on **Bid Committees**. Both courses are fully funded by National Treasury and will once again be presented by Samdi.
- 2.2 A schedules of courses available during 2007/2008 financial year is attached hereunder to enable municipalities to plan ahead for training of operational staff and those who are members of the Bid Committees.
