1. Purpose

- 1.1 To request municipalities to submit a list of officials serving on bid specification, evaluation and adjudication committee.
- 1.2 To request municipalities to submit one (1) nominee that will be attending a bid committee training on 15 –16 October 2007.

2. Background

- 2.1 A bid committee training has been arranged to take place on 15 and 16 October 2007. Prior to this training course, two courses were offered on 28 and 29 May and 31 May and 01 June 2007 in Stellenbosch. To this day, the number of training courses that has been offered, are not sufficient to address a huge demand of officials that still need to be trained.
- 2.2 In addressing a problem of huge demand for bid committee training, Provincial Treasury will first accommodate officials who has not attended any bid committee training on 28 and 29 May 2007 and 31 May –01 June 2007. To this end, we request municipalities to submit to Provincial Treasury a list of officials currently serving on specification, evaluation and adjudication committee. Provincial Treasury will collate this information and take the matter up with National Treasury for assistance in providing more training courses to meet the demand. The granting of further training courses by National Treasury will depend on their available budget.
- 2.3 When submitting a list of officials serving on specification, evaluation and adjudication committee kindly indicate the following;
- 2.3.1 Name and surname of an official
- 2.3.2 Committee which an officials serves on (e.g., spec, evaluation and adjudication)
- 2.3.3 Telephone number and email details
- 2.3.4 Indicate if they have already attended a Bid committee that was offered on 28-29 May and 31 May 01 June 2007.
