FRAUDULENT BANK TRANSACTIONS

- 1. In addition to the communiqué by Financial Institutions and National Treasury, your attention is again drawn to the spate of fraudulent bank transactions, mainly aimed at Government Institutions (National / Provincial Departments, Municipalities) and Corporates.
- 2. The Modus Operandi followed by the fraudsters, have up to now been the following:
- 2.1 A large amount is paid into the bank account of the Institution.
- 2.2 The Institution is then telephonically contacted by the fraudster, informing the Institution that the amount was erroneously paid into the Institutions bank account and requesting that the amount be transferred back to their account.

2.3 This is followed by a poor quality fax, formally apologising for the inconvenience

caused, requesting the refund and supplying the bank details to which the amount must

be transferred.

2.4 The Institution is then contacted on a daily basis to ensure the urgent refund of the

amount.

3. Thereafter, it is then discovered by the Institution that the amount paid into their account

was done by a cheque, which was stopped by the fraudster.

4. It is therefore imperative that Institutions contact their official banker when receiving

request of this nature and further to ensure that the amount paid into their bank account

has been cleared by the bank (normally 7 – 10 days), before even considering the refund

of the amount.

5. Furthermore, it would be greatly appreciated if you could no later than 30 June 2006,

inform the Provincial Treasury of any similar cases, where your Institution was

approached for a refund, in cases, where monies were refunded, details of the bank

account to which the transfer was made, as well as the beneficiary and amount will also

be required.
