### RE: SUPPLY CHAIN MANAGEMENT ROLL OUT PROGRAMME TO MUNICIPALITIES

## 1. Purpose

1.1 To inform municipalities that the Provincial Treasury plan to visit your municipalities as part of the Supply Chain Management roll out programme.

## 2. Background

- 2.1 As previously indicated in circular 11 of 2006, the Provincial Treasury will be rolling out Supply Chain Management to municipalities. The Provincial Treasury is currently at Phase 2 of the implementation and it will assess levels of capacity and competency within the municipalities.
- 2.2 For the purpose of this assessment, a questionnaire has been developed to evaluate the current status in municipalities focusing on areas such as SCM Processes, Delegations, Organizational Structure of the SCM unit, Policy Framework, and Other related matters. This questionnaire is designed to identify areas on which the roll out training will focus. To this end few municipalities have been randomly selected for the purpose of visitation to workshop the questionnaires.

### 3. Request

- 3.1 The CFO's and SCM Heads are requested to peruse the questionnaire as attached herewith and prepare in advance their inputs as well as gather all information and documentation that will be required for the assessment. All aspects of the questionnaire will be work shopped and canvassed with the CFO's and SCM Heads at the visitation
- 3.2 We draw your attention that the assessment will require that you avail yourselves for one whole day to the Provincial Treasury officials that will be conducting the assessment. You are therefore requested to indicate 6 (six) possible dates ( randomly selected within the allocated period) between 03 and 31 July 2006, highlighting the availability of the CFO and Head of SCM as well as SCM staff if necessary to workshop the questionnaire. We will choose one of the dates from which you have indicated to us and the assessment will be conducted between 10h00 to 15H30.
- 3.3 It will be appreciated if the above-mentioned dates can be forwarded to this office via e-mail or telefax on or before 1<sup>st</sup> July 2006, to:
