PROVINCIAL AND LOCAL GOVERNMENT INTERFACE: LOCAL GOVERNMENT MTEC

**ENGAGEMENTS: LG MTEC 2: 20 JANUARY 2006** 

1. I refer to Treasury Circular Mun No. 9 – 2005 dated 26 September 2005, in which the

cycle of local government engagements was communicated to you. Subsequent to

Circular No. 9, the LG MTEC 1 and the one-on-one engagements took place between

provincial departments and municipalities with the specific focus on aligning planning

priorities and development strategies. Based on these engagements, it is assumed that

to the extent possible, that the planning priorities and development strategies have

been aligned between provincial departments and municipalities.

2. The LG MTEC 2 engagement is scheduled to take place on 20 January 2006. The

purpose of the LG MTEC 2 is to inform municipalities of the details of the transfers

from provincial departments to municipalities for the 2006 MTEF. Such information will

include the purpose of the different transfers, conditions and amounts. Premised on the

first budget drafts as well as the transfers of provincial departments, all municipalities

will invariably receive provincial transfers. It is assumed that the actual numbers were

informed by aligned planning priorities and development strategies. Whereas the

planning priorities and the development strategies had to be taken up in the municipal

Integrated Development Plans (IDP's) the provincial transfers should be reflected in

the draft budget.

3. In view of the above, each municipality is requested to be represented by both the

Municipal Manager and the Chief Financial Officer (CFO) at the LG MTEC 2. In

addition, you are requested to confirm attendance inclusive of the names by no later

than Monday, 16 January 2006 with Ms N van Wyk:
