## ADJUSTED ESTIMATES OF PROVINCIAL EXPENDITURE 2006, LOCAL GOVERNMENT **ALLOCATIONS**

1. This circular serves to inform Municipal Managers and Chief Financial Officers of the Provincial Government Western Cape Adjusted Estimates of Provincial

Expenditure, 2006.

2. According to Section 29(3)(a) of the Division of Revenue Act, (Act 2 of 2006)

(2006 DORA) the Provincial Treasury may, despite anything to the contrary

contained in any law, in accordance with a framework determined by National

Treasury, make allocations to municipalities that were not published. In terms of

section 29(3)(b) of the 2006 DORA these allocations must be published in the

Provincial Gazette before any transfers can be made, unless these allocations

were published with its adjustments budget submitted to the provincial

legislature.

3. In this regard the Minister of Finance has tabled, amongst others, the Adjusted

Estimates of Provincial Expenditure inclusive of the adjustments in respect of the

Local Government Allocations by Provincial Departments.

4. In compliance with the 2006 DORA, find enclosed the above-mentioned booklets.

The affected municipalities are requested to effect adjustments to their

projections of income from these allocations, through the passing of a municipal

adjustment budget.
