#### 2. Background

2.1 The Provincial Treasury was given the mandate to monitor and assist municipalities with the implementation of SCM. As part of the Implementation, municipalities are required to have and implement a supply chain management policy which is consistent with current legislation. The implementation of supply chain management for high capacity municipalities came into effect on 1 October 2005 and that of medium capacity municipalities on 1 January 2006.

Provincial Treasury their amended SCM policy or amendments thereof after being tabled before the council. The Provincial Treasury will scrutinise each policy and issue comments therein to each municipality.
