VERIFICATION OF PRIMARY BANK ACCOUNT

Purpose

1.1 The purpose of this circular is to draw the attention of the Accounting Officers and personnel concerned to the contents of section 8(5) and 9(b) of the Municipal Finance Management Act, no 56 of 2003.

2. Background

2.1 Section 8(5) of the MFMA, 2003 prescribes that-

"The accounting officer of a municipality must submit to the National Treasury, the relevant provincial treasury and the Auditor-General, in writing, the name of the bank where the **primary bank** account of the municipality is held, and the type and number of the account. If a municipality wants to change its primary bank account, it may do so only after the accounting officer has informed the National Treasury and the Auditor-General, in writing, at least 30 days before effecting the change."

2.2 Section 9(b) of the MFMA, 2003 prescribes that "the accounting officer of a municipality must submit to the relevant provincial treasury and the Auditor-General, in writing-

Annually before the start of a financial year, the name of each bank where the municipality holds a bank account, and the type and number of each account."

3. Reasons

- 3.1 National Treasury requires such information to update their records and distribute the information to the various National Departments.
- 3.2 National and Provincial Departments require the banking account details to transfer payments to municipalities.

4. Requirements

4.1 Accounting Officers are urgently requested to complete the attached form, as prescribed by National Treasury, and forward the original document, to reach this office by no later than **10 February 2006**, to –
